# **General Discussion Points**

# **Strategic Update**

- SW RSC gave AB members a strategic update at the start of a new academic year, topics included:
  - Update on the Ministerial changes in the Department following the government re-shuffle.
  - Update on the upcoming spending review
    - School measures, academisations, SEND and levelling up place based worked.
  - o Trust review programme.
  - Upcoming advisory board elections.
  - Covid update (restart, testing, vaccinations, LA relationships).
  - Disadvantage gap in the SW.

# **Converter Academy Orders**

Points discussed in relation to school conversion.

**Project:** Whether to approve Hillbourne Primary School, **Bournemouth, Christchurch and Poole** to convert to academy status and join Hamwic Education Trust

#### AB discussion:

#### Governance

 Members discussed the trust's governance structure, notably the need to remove the overlap between the members and trustees.

# Performance

 Members discussed that the trust currently has several challenging schools. Six of its schools have a 'requires Improvement' judgment.

The AB would like to see more evidence of the trust's school improvement impact particularly in terms of Ofsted outcomes of existing schools.

# Other

 Members recognised that there is a viability risk with Hillbourne, as it is currently only at 55% capacity. Members were made aware of upcoming housing developments in the area.

**RSC decision:** Approve with conditions.

Conflicts: None

**Further actions required:** Project lead to inform the school and trust, and share conditions with the trust.

**Project:** Whether to approve the following schools of the Beacon Federation converting to academy status and joining Westcountry Schools Trust:

- Ugborough Primary School, Devon
- Ermington Primary School, **Devon**
- Manor Primary School, **Devon**

## AB discussion:

#### Governance

 Members would like to see progress on amending governance structures at the trust continuing

#### **Finances**

 AB members noted that the reserves held by the trust mean the in-year deficits predicted, if realised, are unlikely to have substantial implications on the Trust's overall financial security.

# School improvement

 Members agreed that the trust had recently strengthened their school improvement capacity, but also want to ensure that the trust is not growing too quickly or taking on too many challenges.

## Other

 Members noted that these schools would provide capacity to the trust and were happy to approve.

# **Trust Change**

Points discussed in relation to academies moving to a new trust.

**Project:** Whether to approve Preston School Academy, **Somerset** (SAT) to transfer to Midsomer Norton Schools Partnership

 Members noted that this proposal fits with the overall growth strategy of the trust to set up a hub in Yeovil now that the Bath hub is fully established.  Members discussed the challenges the trust (and other trusts more widely) are experiencing in recruiting good trustees, LGB members

# School Improvement

• Members noted that the school improvement plan for the trust was comprehensive.

#### Other

 Members discussed the secondary capacity of the trust but noted that improvements are being seen at Writhlington school, evidenced by recent Ofsted monitoring reports

**RSC decision:** Approve.

Further actions required: Project lead to inform the school and trust.

**Project:** Whether to approve Winton Primary School, **Bournemouth, Christchurch and Poole** (SAT) to transfer to The Delta Education Trust

## AB discussion:

#### Governance

 Members noted that the member and trustee boards were well balanced in terms of skills and expertise.

# School improvement

• It was noted that Winton Primary would bring strong KS2 capacity to the trust.

**RSC decision:** Approve.

**Project:** Whether to approve Plympton Academy, **Plymouth** (SAT) to transfer to The Thinking Schools Academy Trust (TSAT).

#### AB discussion:

#### Governance

• AB members raised the issue of trustees sitting on the Academy Advisory Board and noted that it was a temporary measure.

#### Other

- Members recognised that this proposal would consolidate the position of TSAT in Plymouth as well as secure the sustainable future of the hub.
- AB members were made aware that this proposal supports the RDD objective to rationalise the secondary trust landscape in the city by SATs joining strong MATs.
- Members discussed the consultation for this proposal, noting that no issues were raised.

• Members discussed Plympton's finance position and TSAT's financial health.
