Thank you for your email of 20th April requesting the following information:

"To get the in-year spends for each of the programmes listed in the Excel spreadsheet issued as the MoD's annual Equipment Plan report 202-30 for the year 2020-21. The tab is entitled "PPST2020), and runs from "Ajax (Specialist Vehicles)" down to "New Style of IT (Deployed)".

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

The information you have requested can be found at annex A. Some of the information falls entirely within the scope of the qualified exemption provided for at section 22(1) (Information Intended for Future Publication) of the FOIA and has been withheld.

Under section 22(1) of the FOIA The Ministry of Defence (MOD) is not obliged to provide information that is intended for future publication. Section 22 is a qualified exemption and subject to public interest testing which means that the information requested can only be withheld if the public interest in doing so outweighs the public interest in disclosure. In this case, it has been has concluded that the public interest favours withholding the information you have requested.

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that the in-year spend for Dreadnought will be available in The United Kingdom's future nuclear deterrent: annual update to Parliament. The next update will be published in December 2021. The figure will also appear in the Ministry of Defence's Annual Reports and Accounts published in Autumn 2021, available at https://www.gov.uk/government/collections/mod-annual-reports

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact us in the first instance at the address above. If informal resolution is not possible and you are still dissatisfied then you may apply for an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail <u>CIO-FOI-IR@mod.uk</u>). Please note that any request for an internal review must be made within 40 working days of the date on which the attempt to reach informal resolution has come to an end.

If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the
