I am writing about your recent request (Reference: FOI2021/03814) seeking the following information:

Please provide the following records under the freedom of Information:

- 1. The amount spent on purchasing flags in each of the years: 2021 (up to the date of this request), 2020, 2019 and 2018
- 2. For the same time periods, please provide a separate breakdown for spending on the following flags:
- The Union Flag (
- St George's flag
- The flag of the European Union

You subsequently clarified your request (FOI2021/04419), as follows:

I agree to my request being narrowed to cover Union Flags purchased under the central MOD contract for which records are available. Please also provide this in line with the financial years mentioned, plus 1 January to 8 April 2021 In line with your suggestion, please also provide the overall total cost of flags procured against the central contract over the complete time periods.

I have handled your request in accordance with the Freedom of Information (FOI) Act. The information is provided in the following table:

It does not provide details for flags that might have been purchased by individual MOD units who are not obliged to use the contract and are free to purchase flags under their own local arrangements.
