We refer to your email dated 14 February 2021 to the Ministry of Defence Police which was acknowledged on the 15 February 2021.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

- 1) How many cases of stalking were recorded by your police force between March 1st 2020 and February 1st 2021**
- 2) How many cases of stalking were recorded by your police force between:**
 - **January 1st 2018 - December 31st 2019**
 - **January 1st 2017 - December 31st 2018**
 - **January 1st 2016 - December 31st 2017**

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

 - **January 1st 2018 - December 31st 2019** 4

- **January 1st 2017 - December 31st 2018** 8

Note: The search criteria used was for cases under the Protection of Harassment Act (that includes stalking).
