**FREEDOM OF INFORMATION ACT 2000: MINISTRY OF DEFENCE POLICE:  
INDECENT EXPOSURE.**

We refer to your email dated 13 March 2021 to the Ministry of Defence Police which was acknowledged on 15 March 2021.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your emails you requested the following information:

**Please provide data on how many incidents of indecent exposure were reported to police in each of the years 2017 - 2021.**

**Please provide data on how many of these arrested in an arrest and/or charge.**

**Please also supply data on the sex of perpetrators/victims. If it is not possible to provide this for individual incidents, please do this more generally. Eg. Of 200 hundred incidents, there were 100 male victims, 100 female victims.**

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

**Please provide data on how many incidents of indecent exposure were reported to police in each of the years 2017 - 2021.**

2019 – 3 incidents were reported.

**Please provide data on how many of these arrested in an arrest and/or charge.**

One suspect was arrested in connection with 2 of the incidents referred to above and was issued with a Police Caution.

No arrests were made in respect of the other reported incident.

**Please also supply data on the sex of perpetrators/victims. If it is not possible to provide this for individual incidents, please do this more generally. Eg. Of 200 hundred incidents, there were 100 male victims, 100 female victims.**

Perpetrators – 2 males    Victims – 2 female, 1 male
