2	Process	Is there a favoured or prescribed way of making contact with MNO's for this pilot project?	Mobile UK are happy to be facilitate introductions to MNO's by lead local authorities	17/09/2021
3	Clarification	Is the DCIA Pilot competition only for 5G Cellular or can we use WiFi too?	DCIA project is agnostic of wireless communications technology choices. The focus is on enabling the use of Local Authorities' property assets (land, buildings, street furtniture) for deployment of any advanced wireless networks infrastructure. While it is expected that 5G network rollouts will drive most of the interest, 4G, LPWAN, WiFi, etc. are all relevant for consideration.	17/09/2021
4	Clarification	Please confirm scope is whole of UK and benefiting 5G but also wider telco infrastructure as well ?	Yes it is the whole of the UK. We are focussed on publicly owned assets. Please refer to Competition Application Guidance material for more information about this.	17/09/2021
5	Clarification	Were there any Street Lighting solution providers involved in the Tech Spec build?	No Street Lighting solution providers were involved in Digital Platform Technical Specification, but we would welcome their invovement in another DCIA prgramme stream (Smart Infrastructure Standards) which is due to commence soon. 6	Clarification	Who will 'own' the final platform ? Is this going to be hosted by .gov. uk ?	There is no intention for Central Government to develop or host a platform. We expect multiple platforms to be used in pilots, provided by a range of platform providers. Following the pilots we will draw upon learnings and further stakeholder engagement to understand whether further interventions are needed to ensure long term sustainability of solutions (ref. section 2.2.7. in the Application Guidance).	17/09/2021
7	Clarification	Can an area such as Dorset bid for DCIA without a "Regional" partner. Some of the language being used seems to be suggestinga bid must be led by a regional authority? We are planning on leading a bid as Dorset Council working with a number of partners but without any "regional authority" participation. Would that be OK?	Please refer to the application guidance document :- Lead regional applicants will be accepted on the basis of existing political/geographic entities (regional authorities). We will also consider applications from a group of multiple Local Authorities that have a contiguous geography, these applicants will be asked to demonstrate a signed collaboration agreement between themselves prior to any claim to DCMS for grant funding for the pilot. In summary, applications from groups comprising only one participating Local Authority will not be considered as this will not allow the pilot to fulfill its objectives (ref. sections 2.2.1. and 2.2.2 in the Application Guidance). To be considered, applications should include participation of at least two and preferably several Local Authorities within a regional authority or a representative body (ref. 8	Clarification	Will the opportunity to look at Public Assets include state aided funded infrastructure i.e. Masts built as part of the DCMS Superfast programme.	We welcome the addition of other asset data sets into the platform, as long as it is an addition to Local Authority asset data. This is covered in section 3.2 of the DCIA Competition Application Guidance - "It is not mandatory for bidders to include asset owner organisations and their asset data other than Local Authorities, however those that do will have an advantage. 9	Clarification	Is this competition focussed entirely upon asset management or is there any scope for innovative passive equipment to improve physical infrastucture?	The aim of the pilots is to accelerate access to public sector assets as candidate sites for wireless connectivity. There is no scope to assess or recommend changes to passive or active equipment.	17/09/2021
10	Clarification	Could an asset owning organisation, someone like Highways England, act as the lead?	We are looking for a regional authority, a group of local authorities, with one to be the lead applicant. Highways England can be involved with a local authority, but as a lead no.	17/09/2021
11	Clarification	Is it capital and revenue funding support?	All our Grant funding is capital expenditure in regards to DCMS. For the grant recipient organisation, costs might be capitalised under accounting principles as long as they are within UK regulations and provide calculations to DCMS. 12	Clarification	Is the Technical Specification available to LAs?	Yes. Draft Technical Specification is publicly available to access within the collection of DCIA competition supporting documents. The final version of the Technical Specification will also be publicly available in the autumn of 2021 subject to any additional stakeholder input. 13	Clarification	Is it possible to be a supplier to multiple responses?	Yes. There is no limit on how many applications each supplier can support.	17/09/2021

14	Clarification	What are seen as the biggest barriers to communicating with Citizens?	The aim of the pilots is to accelerate access to public sector assets as candidate sites for wireless connectivity. Working with DCMS, DfT and other organisations, successful pilots will be expected to plan, support and deliver communications activities to ensure the benefits of the project(s) are demonstrated and shared as widely as possible.	17/09/2021
15	Clarification	How does subsidy control work with Northern Ireland?	The Subsidy Control team at the Department for Business, Energy & Industrial Strategy (BEIS) has lead responsibility within the UK for coordination and development of policy on subsidy control. 16	Clarification	Has there been consideration of the potential role of the three devolved Gvts in the project?	Yes, representatives from the three devolved nations have been engaged so far.	17/09/2021

We are looking to collaborate as much as possible, to take advantage of progress that's been made in other areas. 23	Clarification	Will towers built for ESN also be included ?	We welcome the addition of other asset data sets into the platform, as long as it is an addition to Local Authority asset data. 25	Clarification	Does this competition apply to the whole of the UK?	Yes, we've had good engagement from all devolved nations so far.	17/09/2021
26	Clarification	What is the role for Universities?	We recommend a conversation with the local authority, that the University is within, to explore the role that can be played.	17/09/2021
27	Clarification	What percentage of project costs are covered by the grant?	DCMS will fund 100% of costs bourne by Lead Regional/Local Authorities. Where there is onward granting, Authorities will have to ensure that this is undertaken in a subsidy control compliant manner as outlined in the competition guidance. 28	Clarification	Can "assets" include mobile assets ?	We are not 100% sure what is meant by "mobile assets", but we welcome the addition of other asset data sets into the platform, as long as it is an addition to Local Authority asset data. This is covered in section 3.2 of the DCIA Competition Application Guidance - "It is not mandatory for bidders to include asset owner organisations and their asset data other than Local Authorities, however those that do will have an advantage. Some examples of other asset owning organisations are other public infrastructure operators (rail, road, utilities), NHS, large public estates, commercial landlords, private sector data aggregators and brokers, and many others. 29	Clarification	If we are already in the process of doing this kind of engagement, how would that work?	We encourage applications from regions and local authorities at different levels of maturity in their application of a solution. In circumstances where a Local Authority has already made progress in digital asset management, we see an opportunity to test further scaling up and wider regional adoption of the approach.	17/09/2021
30	Clarification	Are cross border applications, e.g. acoss England and Scotland, possible?	Yes, as long as a collaboration agreement is in place according to the competition guidance. Also taking into account the special consideration for the funding routes. If further input from finance is required on such an approach we can follow-up with finance team.	17/09/2021
31	Clarification	Are there plans to merge/synergise any government strategies on facilitating/mapping fibre connectivity with this Pilot Competition?	Yes, DCMS have enaged with other government programmes, such as BDUK and NUAR, to ensure cross programme alignment. Section 3.4 of the Digital Platform Technical Specification also covers this point.	17/09/2021
32	Clarification	Is there guidance on identifying technology partners as a Local Authority?	To a degree yes, through information provided within the Draft Technical Specification and by identifying required capabilities in the Application Guidance (ref. section 3.2). We also hope that the networking tools we have made available will help Local Authorities identify technology partners of interest.	17/09/2021
33	Clarification	Given there is not currently mass small cell roll out in all parts of the UK, how will this factor in to the evaluation? Will certain areas of high commercial interest be rated higher than others?	The underlying process to access a local authority asset is the same in high or low demand areas, so the problem being addressed is the same in both areas. Section 2.2.1 and 3.2 of the Competition Application Guidance explain the geographical criteria for a successful bid. The programme aim is to cover a broad range of diverse geospatial and socio-economic characteristics within the pilots.	17/09/2021

34	Clarification	What is the weightage on use of AI and Machine Learning to predictive and prescriptive analytics solutions ?	Not in scope for this project	17/09/2021
35	Clarification	What is the thinking beyond the pilot. Is there likely to be funding made available for local authorities to catch up with the successful areas in order that they can also have these digital platforms.	Following the pilots we will draw upon learnings and further stakeholder engagement to understand whether further interventions are needed to ensure long term sustainability of solutions (ref. section 2.2.7. in the Application Guidance).	17/09/2021
36	Clarification	Can multiple applications be made by a lead applicant to include various contigiuos local authorities?	Yes	17/09/2021
37	Clarification	What is the max grant amount for research organiations as partners?	The competition guidance document outlines the eligibility criteria for proposals led by any local or Regional Authority. These lead authorities will need to ensure that any onward granting (including to any research organisations) is undertaken in a subsidy control compliant manner.	17/09/2021
38	Clarification	Do you see a role for neutral hosts in partnering with local authorities?	Yes, we are open to receiving bids that address this approach	17/09/2021
39	Clarification	The guidance highlights role of a 'neutral convener' - could you describe this role?	A role of a 'neutral convener' is an option whereby an independent party could be introduced to act as a platform operator and a provider of neutral brokerage service to asset owners and asset users.	17/09/2021

42	Clarification	Could an asset management expert from the Republic or Ireland partner with a UK LA ?	Yes, as the Local Authority will be UK-based. Is more than one local authority required?	Applications from groups comprising only one participating Local Authority will not be considered as this will not allow the pilot to fulfill its objectives (ref. sections 2.2.1. and 2.2.2 in the Application Guidance). To be considered, applications should include participation of at least two and preferably several Local Authorities within a regional authority or a representative body (ref. 49	Clarification	The grant conditions state that "the total sub-contracting cost for the Project must be limited to 30% of the Total Project Costs". Please can you confirm that the costs of providing the platform itself is not included within this 30%.	We have identified an error within the Grant Funding Agreement Template document Annex 4. The 30% limit of total project costs for subcontracting does not apply for this competition. We will be uploading a corrected version of the document shortly.	17/09/2021

50	Clarification	If successful, do you envisage DCMS signing a grant agreement with the lead LA and then the LA procuring the digital platform and other private sector inputs required?	The most appropriate approach to securing the use of a platform will depend on specific circumstances and supporting processes of each lead authority. In general, we envisage a couple of likely approaches.	24/09/2021
			First one of these is that given the nature of the pilot, and subject to an internal review and approval, a lead authority may be able to onward grant funding for fundamental research and development work. This would require some investment from the platform provider, and might be competed or awarded in line with internal policies.	
			The other possible approach, given the relatively low value of funding allocated to a platform provider (possibly below internal procurement thresholds), is to use a light-touch evaluation or direct award to a preferred supplier.	
			The key consideration for any chosen approach is that it should be relatively fast so as not to jeopardise overall ability of the applicant to deliver the pilot within timelines specified in the competition guidance. Preferably the selection of a platform provider should take place as part of the competition bid preparations, with the supplier funding conditional on the bid itself being successful.	
			Finally, we would also encourage all applicants to consult with their industry partners in the pilot, Mobile Network Operators and other telecommunication infrastructure providers, with regards to selection of a suitable platform.	
51	Clarification	Will bidders need a single, confirmed, platform provider on-board at the time the application is made (18 November)?	Yes, preferably we would expect the bid response to include a single confirmed platform provider.	24/09/2021
			We recognise the challenge of securing a participation of a platform provider before the deadline for submission of applications, but believe there are suitable approaches to do so relatively quickly. Please refer to our Q&A response to previous related questions for further details.	
52	Clarification	Could a pilot area trial more than one potential platform / provider as part of the same project?	No. We'd discourage a pilot area from using more than one platform as this would introduce significant complexities to the delivery of the project, specifically the ability of each pilot to manage complex data sets and execute test cases across multiple Local Authorities within given timelines.	24/09/2021
53	Clarification	Are potential technology partners required to have headquarters in the UK to be acceptable within the terms of the competition?	The competition guidance does not preclude organisations whose headquarters are outside the UK so long as the work that partner is delivering on the project is within the UK and that any additional Lead Bidder requirements are met.	24/09/2021
54	Clarification	Have all the questions that were asked in the briefing event been captured in this question and answer log?	Yes, all questions that were asked in the live event have been captured in this log, including the ones where answer was given on the day of the event. The live briefing is also available to review here.	01/10/2021
55	Clarification	Would a local authority which has an active exclusive concession contract for access to lamp columns in place be eligible for applying for funding?	Yes. Pilots can and should include data on multiple asset types (land, buildings and street furtniture) notwitstanding any current contractual arrangements.	01/10/2021
56	Clarification	Can you please clarify the expected role of Industry is in the pilot?	The expected role of Industry is to be an active part of the consortium in the testing phase, to test the platform(s) as part of their operational processes and tools, and then report back on the findings against the test cases.	01/10/2021
57	Clarification	Can the competition funding be used for a group of authorities to map their assets so that these are ready for the next stage of deployment?	Yes. Please refer to the Competition Guidance sections: 2.2.1 (Competition Objectives), 2.2.5 (High Level Test Cases) and 2.3 (Funding), all of which reflect the management of asset data by Local Authorities as central to delivery of the pilots, and the funding assistance provided towards it.	01/10/2021
58	Clarification	Should an individual bid ideally cover a mix of geographies (urban sub-urban and rural), or is it preferable for an individual bid to focus specifically on either urban or rural (i.e. one or the other)?	If an applicant's region includes diverse geographies within its boundaries (urban, suburban and rural) than we would expect these to be included in the scope of the pilot test case execution. In those cases where a region has limited geographic diversity (e.g. a predominantly metropolitan or rural region) we will consider a more limited range of geographies as long as an effort has been made to include some degree of variety.	08/10/2021
59	Clarification	Is securing a service or product from a partner for the purposes of the pilot project in any way affected by Subsidy Control? Does the method of procurement impact on this at all?	Assuming that the organisation has a grant agreement with the local/regional authority in question, generally purchasing of any service as a subcontract should be undertaken at cost and consistent with subsidy control.	15/10/2021
60	Clarification	Would the element of a Digital Asset Management Platform that illustrates current mobile coverage be an eligible cost for funding if the intention was that this data could inform the discussion with MNOs over where assets might be deployed for use?	While we expect that the platforms selected for use in the pilots should meet Technical Specification guidance as a minimum requirement, a selected platform may and is likely to contain richer set of features and functions. Decision on which features to include for use in the pilot should be based on the agreement between the lead authority, its telecom industry partners (including participating MNOs), and the platform provider. Assuming this agreement between partners is in place, overall funding amount for use of the platform will be acceptable as long as it is reasonable and proportional to other elements of the pilot and subject to the overall funding limit for each pilot.	15/10/2021
61	Clarification	Technical Specification document advises caution with respect to including mobile coverage data and fibre availability maps within a platform on grounds of security and commercial confidentiality. Would these be acceptable features of a selected platform if it was possible to control their visibility by logon credentials?	With respect to mobile coverage data, we would advise that the lead authority discusses this with its telecom industry partners and particularly with participating MNOs. MNO and industry partners should agree to inclusion of coverage data prior to it being added to the scope of platform functionality. With respect to fibre availability maps, it is evident that majority of stakeholders recognise the value in including these in the scope of the pilots. However, there are some clear risks to critical infrastructure security associated with the inclusion of this data. We welcome proposals from applicants to include for availability data in their approach, subject to further guidance from government's security agencies on the use of this information. Please refer to the test case 7 in Section 2.2.5 of the Pilot Application Guidance document.	15/10/2021
62	Clarification	Would the provision of asset survey services to bring the quality of all asset data up to an agreed quality, description and standard of metadata entries be an eligible cost for funding?	Yes. In general, project management costs are eligible for funding. Efforts which are clearly aimed at ensuring that accurate asset data is available within the pilot will be considered as acceptable, as long as costs are reasonable and proportional to other elements of the pilot and subject to the overall funding limit.	15/10/2021

63	Clarification	Would the project management costs of consortium partners to deliver their element of the solution be eligible for funding? Would these be 100% fundable rather than subject to Subsidy Control percentages?	Project management costs are eligible. Given that the local or regional authority will be managing any onward granting/contracting they will have to make the determination. All costs across one grant partner should be at the same subsidy rate.	15/10/2021
64	Clarification	Can you please confirm that where small businesses can claim back 60% of the costs incurred, 50% for medium businesses, etc, for public/3rd sector organisations 100% of costs incurred can be claimed.	This is for the local/regional authority to designate as DCMS are only funding Local/Regional Authorities directly. By and large the subsidy rates listed here are correct when it comes to experimental development.	22/10/2021
65	Clarification	Can the funding be used to fund an existing post, either in part or in full, if the time paid for is fully allocated to delivery of the DCIA project? Can the funding be used to also cover the on-costs for any post, whether newly recruited or existing as above?	Yes. With regards to on costs, LAs can claim for overheads in the finance form.	22/10/2021
66	Clarification	What happens if there is underspend by the consortium at the end of the project?	Spend is paid in arrears, if spend isn't incurred, grant payments will not be made for the associated under spend.	22/10/2021
67	Clarification	If a lead LA has a track record in securing agreement from their two- tier authorities in working through a central funding allocation with the lead LA as the Accountable Body. Then, for the purposes of the pilot could they draw up their own collaboration agreement to sign with the authorities or does DCMS envisage drafting one to send to us? Would this be separate to any Grant Agreement?	DCMS would review any collaboration agreement to ensure that it meets minimum standards. But it doesnt dictate a specific set of words (we can offer an example if required).	22/10/2021
68	Clarification	We have already carried out significant data collection and categorisation across our local authorities and we already have learning to apply to several of the test cases. Can we apply this learning, or would we be expected to carry out additional intelligence gathering activity?	We certainly encourage all regions to apply relevant previous learnings to the delivery of the pilot as much as possible. Whether further sourcing and cleansing of asset data will be required will depend on specific circumstances of each region. This may be needed in order to bring in additional local authorities into the pilot, to extend the range of asset types included in the data, to address specific industry requirements, etc. Technical Specification document may reveal some of these additional requirements but again, much will depend on the context of the region and needs of its supporting partners.	22/10/2021
69	Clarification	Is there any advice that can be provided on the basis on which a local authority is able to spend money with a pre-selected companies?	DCMS is funding the Local or Regional Authority, they can propose spend in different ways consistent with their own grant and procurment policies.	22/10/2021
70	Clarification	Guidance states "All Pilot Leads, Participants and Partners in selected projects must sign up to the 5G Testbeds and Trials" - Can we obtain a copy of the Programme Participation Agreement	The Programme Participation Agreement is available on the DCIA website here	22/10/2021
71	Clarification	Public perception of 5G can sometimes be negative and prompt the community to contact their Local Authority. Are there any resources available such as proactive communications been drafted by DCMS to assist in such enquiries?	We recognise the importance of providing clear and accurate information about 5G to communities. UK5G will shortly be running five regional workshops for local authorities and LEPs across the UK, which you may find helpful to attend. More details are available on the UK5G website.	22/10/2021
