Thank you for your email of 22 April 2021 to the Ministry of Defence (MOD) requesting the following information:

"Please can you provide me with the following information:

- 1. How many Berlin Airlift GSMs have been awarded since they were instituted?
- 2. How many Berlin Airlift GSMs were awarded each year since this medal's institution?
- 3. A full breakdown of how this medal was awarded by categories of eligibility
- 4. How many groundcrew were awarded the Berlin Airlift GSM?"

A search for the information has now been completed within the MOD and I can confirm all information in scope of your request is held.

Records indicate that 74 Berlin Airlift General Service Medal's (GSM) have been awarded since they were instituted. A breakdown by year can be found in the table below:

The medal was issued to one member of the Army, 71 members of the RAF, one member of the Royal Navy and one civilian.

No ground crew were awarded the Berlin Airlift GSM as the medal was only issued to air crew who met the criteria for the medal, which was; Air crew, service or civilian, who completed one operational sortie on the Berlin Airlift between the Western Zones of Germany to include Bases Schleswigland, Wunstorf and Celle and the city of Berlin to include Templehof Airport (American Base), RAF Gatow (British Base) and Tegal Airfield (French Base) between 25 June 1948 and 6 October 1949.
