# **General Discussion Points**

### **Advisory Board Process**

- Members received an update on the upcoming Advisory Board elections. Members were advised that registration is now open and nominations will be accepted up to 29 October at 5pm.
- Polls will open on 22 November and close on 10 December 2021.
- The RSC noted that she will consider her options for co-opted and appointed board members following the outcome of the elections.

### **Converter Academy Orders**

Points discussed in relation to school conversion.

**Project:** Whether to approve the following schools converting to academy status and forming a new trust: The Dunstan Catholic Education Trust

- Corpus Christi Catholic Primary School, North Somerset
- Our Lady of Mount Carmel Catholic Primary School, Somerset
- St Gildas Catholic Primary School, Somerset
- St Joseph's Catholic Primary School (Bridgwater), Somerset
- St Joseph and St Teresa Catholic Primary School, Somerset
- St Joseph's Catholic Primary and Nursery School, Somerset

#### AB discussion:

#### Leadership:

 The Board considered and discussed the trust's leadership structures and advised that the project lead assist the trust to source a mentor for the CEO and newly appointed CFO.

#### Governance:

- AB members discussed the benefits of a diverse board of trustees and members.
- The spare member was discussed, AB members questioned whether this should be the Chair of Directors.

#### School Improvement:

- AB members recognised further development is needed to support the trust's school improvement strategy as it develops.
- AB members noted the progress data of the schools and discussed the importance of school improvement plans.

#### Other

• AB members were clear that there was considerable strength in this group of schools and that with the correct structures in place the MAT has strong potential.

#### **Conditions:**

- The CEO and CFO should each have an experienced mentor in place, and to build a strong partnership with another trust.
- Expand on the Trust's school improvement plans, especially for St Gildas.
- That the Trust has termly review meetings with RDD, as a further support, for the first two years following formation.

#### Leadership:

• AB members discussed the challenges of operating a new multi academy trust and advised that the project lead assist the Trust to source a mentor for the CEO and CFO.

#### Governance:

• AB members considered the current membership of the trustee board's and noted the important role of trustees, and the difficulty with hiring new and experienced members.

#### School Improvement:

• AB members noted the importance of supporting sponsored academy conversions.

#### Finances:

- AB members discussed the advantages and disadvantages of having a part-time CFO.
- AB members queried the top-slice figure.

#### RSC decision: Approve with conditions

#### **Conditions:**

- The CEO and CFO should each ideally have an experienced mentor in place and should request advice on their top-slice.
- Organise termly meetings with RDD to provide updates on the trustee board membership.

#### Conflicts: None.

Further actions required: Project lead to inform the school and trust.

**Project:** Whether to approve Greenmeadow Primary School, **Swindon** to convert to academy status and join Blue Kite Academy Trust.

#### AB discussion:

#### Governance:

- AB members noted the strong skillset of key members in the trust.
- Members noted that the Chair of Trustees was very proactive on matters of financial governance.
- AB members discussed the member/trustee overlap, best practise advises that Members should not be Trustees.

#### Finances:

- AB discussion took place on the growth of the trust and its development in the long-term.
- AB members noted that reducing the form of entry from 1.5 to 1 was a credible move.
- AB members discussed the SMRA visit, and EFSA are supporting the trust to incorporate the review and implement recommendations.
- An EFSA official advised that the financial forecast of the trust is healthy.
- Members noted the RAGF and MDIF funding that the trust has received and noted that the trust is building capacity ahead of growth.
- Members discussed the financial vulnerability of Greenmeadow but were content that there were already plans in place to address this.

#### Other:

- AB members discussed the importance of having a growth strategy in place.
- Blue Kite have been supporting Greenmeadow as part of their Covid support scheme so there is a strong partnership already in place.

#### School Improvement:

• Members noted the good school improvement record of the trust.

- Ab members wanted to know more about the pupil experience committee, and the accountability for that group in terms of the wider governance of the trust.

- AB members noted that this would bring mutual benefits for both schools and that Severnbanks would bring capacity to the trust.
- AB members were pleased that SFAT is already growing as a new trust, as capacity is needed in the area especially at primary.
- AB members were pleased to see the connection that had been made with the LINK Academy Trust in Devon who have expertise in running a trust with small rural schools.
- AB members noted that the Diocese of Gloucester are in support of the English Bicknor proposal and have confidence in The Severn Federation Academy Trust.
- AB members noted that English Bicknor is geographically isolated and not engaged with local networks and will benefit from the support of the trust.
