Thank you for your email of 17 May 2021 to the Ministry of Defence (MOD), requesting the following information:

"With reference to the above Act, can I please request the medal entitlement of the following individual, and their date issued? Also a copy of the ww2 medal card if issued?

Walter Frederick Jaggs Jaggs was born in West Norwood, London in 1899 (over 116 years ago). He passed away in 1969 (more than 25 years ago) Birth record and death records are attached. The reason I would like these for private research. Thank you and best regards"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that none of the information in scope of your request is held. The Ministry of Defence Medal Office (MODMO) have undertaken a search and cannot find any Second World War medal card for the late Mr Jaggs.

Under Section 16 of the FOIA (Advice and Assistance), you may wish to be aware that the original Air Ministry folder, which has been located, records Mr Jaggs as joining the Royal Flying Corps in 1917 as a Lance Corporal and having served in France from 18 August 1918. However, the document records no medals entitlement and no First World War Medal Card was located. He appears to have gained a Commission in 1924 as a Pilot Officer but there is no further documentation other than the intention for him to train at Brough on Twin Engine aeroplanes in the early 1920s.

I should also confirm that the MODMO does not hold issue dates for World War One (WW1) or Gallantry awards as all WW1 records were transferred to the National Archives and are accessible to the public.

The National Archives will also hold any records of units where the late Mr Jaggs served. Further information about how to obtain such information can be found at the following link:
