You requested the following information:

## "MAJOR WILLIAM WILLIAMS MM TD ROYAL ARTILLERY

I am writing to request under the Freedom Of Information Act (FOIA) the complete medal entitlement, their award and issue dates together with a summary units in which the above named serviceman served"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the MOD and I can confirm some information in scope of your request is held.

I can confirm that Major William Williams was awarded the following medals:

Military Medal
Territorial Force Medal
Victory Medal
British War Medal
Territorial Decoration (Listed in London Gazette 26 February 1942)

Defence Medal Issued 2 November 1948 War Medal Issued 2 November 1948

Under Section 16 of the FOIA (Advice and Assistance) you may wish to be aware that the MOD Medal Office does not hold issue dates for World War One (WW1) or Gallantry awards as all WW1 records were transferred to The National Archives and are accessible to the public.
