



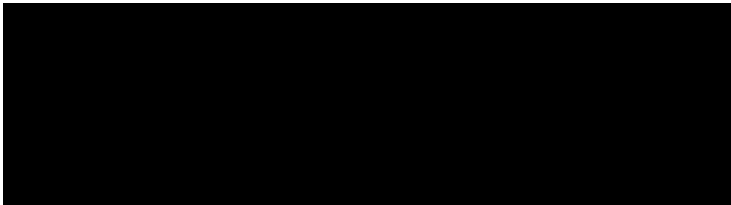

In answer to Question 1, please see the below completed table. However, you should note that the versions of the technology are withheld under the following exemptions:

- Section 24(1) – Information which must be withheld in order to safeguard National Security.
- Section 26(1)(a) and (b) - Information which, if disclosed would prejudice defence or the capability, effectiveness or security of relevant forces.
- Section 31(1)(a) – Information which, if disclosed would prejudice law enforcement.

As all three Sections are absolute exemptions, there is no requirement to consider the public interest in making the decision to withhold the information.
