## **Sponsor Application**

Points discussed in relation to applications for becoming a sponsor. .

**Project:** Discuss whether to approve Minster Trust for Education (MiTrE), Nottinghamshire becoming a sponsor

#### AB discussion:

The Minster School is a National Support School, a former teaching school and a Maths Hub. The trust is a strategic partner of the Redhill Teaching Hub.

All seven schools in the trust are rated good or outstanding, creating capacity and expertise to support schools in the local area. The trust has applied to become a sponsor to allow it to sponsor underperforming schools and increase the number of academies in the trust. The trust expects to sponsor schools within its current area of operation.

The current and future financial health, and strength of financial management and governance at the trust were considered.

**RSC decision:** Approve

**Further actions required:** Delivery Lead to inform the trust of the decision and recommendation of an external review of governance.

## Free School Presumption - Sponsor Approval

Points discussed in relation to sponsorship of a free school.

**Project:** Discuss sponsor options for Barugh Green MU1 Free School, Barnsley

#### **AB** discussion:

The academy will be a 1.5 form entry primary school (315 places), with the view to expand pupil places in the future should the need arise. The academy is required to meet basic need for school places in the area due to a local housing development.

The LA is arranging for the building to be funded via S106 agreements with the developer, as part of their requirements for MU1 is to provide a new primary school. The LA will be funding pre-opening revenue costs and underwriting financial shortfall if pupil numbers are lower than anticipated. The final amounts to be finalised between the LA and the trust in due course.

The proposed opening date is September 2023. The site and building for the school will be transferred to the successful trust on a lease arrangement.

9 trusts applied to sponsor the school, and 5 were taken through to the interview stage. The LA's preferred sponsor is Delta Academies Trust.

The trust has a proven track record as a sponsor and has schools in the vicinity to provide support.

The financial health, strength of financial management and governance at the trust and the impact on the trust's future financial health if it sponsored this free school were considered.

# **Trust Change**

Points discussed in relation to academies moving to a new trust.

**Project:** Huttoft Primary School (Single Academy Trust), Lincolnshire, to transfer to Horncastle Education Trust (Multi Academy Trust), Lincolnshire.

#### AB discussion:

Ofsted judged Huttoft Primary School as requires improvement on 26 February 2020.

The academy has an established working relationship with Horncastle Education Trust and would benefit from formally joining the trust, having access to greater school improvement support and finance and resource management.

The financial health, strength of financial management and governance at the trust and the impact on the trust's future financial health if Huttoft Primary School joins were considered.

A supportive deployment of a School Resource Management Adviser (SRMA) to Horncastle Education Trust was recommended.

## **Sponsored Route:**

Points discussed in relation to sponsorship of a school.

**Project:** Discuss sponsor options for Kirkby College, Nottinghamshire

### **AB** discussion:

In March 2018, Ofsted deemed Kirkby College to be inadequate and a termination warning notice was issued on 21 June 2018.

Kirkby College has been included in the second round of the School Rebuilding Programme; this capital investment will provide the long-needed improvement required to the school buildings.

The board considered proposals from three trusts to sponsor Kirkby College.

The financial health, strength of financial management and governance of each trust and the impact on the trust's future financial health if Kirkby College joins were considered.

The board agreed that Outwood Grange Academies Trust (OGAT) was the preferred sponsor. The trust has a strong track record of supporting and improving schools and the board's view is that OGAT would bring benefits to the wider Ashfield area.

RSC decision: Approve OGAT as the sponsor for Kirkby College
