We refer to your email dated 13 July 2021 to the Ministry of Defence Police which was acknowledged on 14 July 2021.

We are treating your email as a request for information in accordance with the Freedom of Information Act 2000 (FOIA 2000).

In your email you requested the following information:

1. How many missing persons cases have been filed (from Jan 2016-June 2021) in your police department?

1i. Within this, could you split it up by ethnicity (specifically how many are Caucasian, Asian and Black)?

1ii. Could you also split the data up by gender (but I would like to know how many are Black males, white females, etc)?

2. Could you tell me of the number of missing Black people filed in your police department from 2016-2021, how many were under the age of 18?

A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.
