## **Authorized Amendment**

RA 4800: The major updates to Issue 10 includes; AMOs shall provide the Type Airworthiness Authority (TAA) and the Military Continuing Airworthiness Manager (Mil CAM) an extant copy of the organization's approved supplement, updates to EASA and CAA policies and references due to the UK leaving the EU and update to the supplement due to current differences between CAA Part 145 & MRP Pt 145 regulations.



RA 4806: The major updates includes; gender neutral terms throughout, Accountable Manager (Maintenance) guidance for MMOs, Human Factors training is required in induction training and EASA and CAA policy and reference changes due to leaving the EU.

RA 4807: The major updates includes EASA and CAA policy and reference changes due to leaving the EU.

RA 4810: Added footnote referencing the use of a TAM, changing responsibility from Mil CAMO to Mil CAM.

RA 4812: Changes update; information on electronic signautes, reference to RA 4945(3) added for Part-M task authorizations and changes to criteria for removing components as serviceable from an Air System for AMOs

RA 4813: Added Regulation 4813(4), 'Management of Maintenance Documentation on Delivery or Transfer of an Air System', previously withdrawn from RA 5502, changing responsibility from Mil CAMO to Mil CAM.

RA 4814: References updated in 4814(1).

RA 4815: The addition of regulation for the handling of identification information for any Product, Part or Appliance previously in RA 5885(2), Air System changed to Aircraft where appropriate and quality references updated, changing responsibility from Mil CAMO to Mil CAM, Aircraft changed to Air System as appropriate.

RA 4816: Rationale update, email details for MAOS applications updated and a new Regulation, 'Distribution of Approved Maintenance Organization Exposition' added, Aircraft changed to Air System as appropriate, changing the responsibility from Mil CAMO to Mil CAM.

RA 4817: Rationale update, information for AMOs carrying out maintenance at temporary locations, Aircraft changed to Air System as appropriate and references updated, changing responsibility from Mil CAMO to Mil CAM.
