PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about livestock numbers, which we received on 7 June 2021. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and our response is detailed below:

- "1. Please could you supply the current numbers of livestock farms and the current numbers of livestock held on each of these farms for the following species.
- a. Poultry Broilers.
- b. Poultry Layers.
- c. Pigs.
- d. Sows.
- e. Dairy Cattle.
- f. Beef Cattle.
- g. Sheep."

The information you have requested can be found at Appendix 1.

As you are aware from your previous requests for the same information (ATIC2236) pigs are not separated by sows.

The information provided is the average population of livestock passed to the APHA when a premise is initially registered. The 'usual stock numbers' are the numbers of livestock provided by the keeper upon registration. As part of the registration process, APHA ask the farmer what their usual stock numbers are, and this is recorded on an APHA database. It is the responsibility of the owner/keeper to keep APHA informed of any number changes. APHA do change the numbers if informed of changes by visiting officers, other APHA offices or by checking the Cattle Tracing System (CTS).

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

Any blank entries for livestock numbers or those with 0 is because there was no stock to record at the time of registration and APHA have not been informed since of any changes by the owner/keeper.

Part of the information that you have requested has been exempted from release under Section 40 of the Freedom of Information Act (FOIA) 2000.

Section 40

We confirm that APHA does hold the information that you have requested as detailed above, but we have decided that some of the information should be withheld under sections 40(2) and 40(3A) of the FOIA as the information constitutes personal data relating to persons other than you.

These sections exempt personal information from disclosure if that information relates to someone other than the applicant, and if disclosure of that information would breach any of the data protection principles in Article 5(1) of the General Data Protection Regulation (GDPR).

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy. We consider that disclosure of this information is likely to breach the first data protection principle, which provides that personal data must be processed lawfully, fairly, and in a transparent manner. Disclosure would not constitute 'fair' processing of the personal data because, it would lead to the identification of 3rd parties.
