# PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about live exports of cattle, sheep and pigs - EU BCP's 2020 data which we received on 09 June 2021. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and our response is detailed below:

"We are in negotiations with a potential site near Calais and to support their efforts to secure investment they have asked if we had data for the volumes/consignments by species for 2020. Could you provide this please."

The below table shows the number of journey logs APHA have issued for exports via Calais BCP, split by species. APHA only record EU BCPs on those exports that require journey logs. This is not a reflection of number of animals exported, as multiple animals can be covered by one journey log.
