## **PROVISION OF REQUESTED INFORMATION**

Thank you for your request for information about game bird imports, which APHA received on 21 July 2021. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and our response is detailed below:

"I'd like to request the following information under the Freedom of Information Act 2000:

1. The number of pheasants imported into the UK from overseas in 2019, as poults, chicks and/or eggs for hatching, with this figure broken down by each country of origin.

2. The number of partridges imported into the UK from overseas in 2019, poults, chicks and/or eggs for hatching, with this figure broken down by each country of origin.

3. The number of pheasants imported into the UK from overseas in 2020, poults, chicks and/or eggs for hatching, with this figure broken down by each country of origin.

4. The number of partridges imported into the UK from overseas in 2020, poults, chicks and/or eggs for hatching, with this figure broken down by each country of origin."

And clarity regarding the request:-

"Would it be possible to receive the above information, including all countries other than the UK?"

Please see the information you have requested at Appendix 1. Animal and Plant Health Agency (APHA) has access to UK statistical data from the EU Commission's Trade Control and Expert System (TRACES) system, for commercial imports and exports. The information extracted from here is a true reflection of the information that we have access to.
