Thank you for your email of 30 May 2021 requesting the following information:

“I am making an inquiry for Stolen Valour Canada regarding how many UK Gulf War Medals went to Canadians (both civilian and military). There appears to be no online records to give this type of information, so I thought your department might know.”

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD) and I can confirm that some information in scope of your request is held.

The Gulf Medal 1990-1991 was issued in accordance with Defence Council Instruction 185/91, which allowed Canadian Forces to receive the award. The requirement was for the Unit to provide nominal rolls, which were lists of individuals nominated for the award, to the MOD Medal Office by way of application. These rolls are still held by the MOD.

The number of Gulf Medals (1990-1991) issued to Canadian citizens, according to the nominal rolls held are as follows:

Please note, the Ministry of Defence does not have any access to Canadian service records, therefore has no sight of any applications made retrospectively after the nominal rolls were submitted to the MOD.
