RE: Request for Information – RFI3676

Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

- *The amount of money Homes England has spent in total on purchasing land intended for development (or for resale and development) annually during the financial years 2016/17, 2017/18, 2018/19, 2019/20, 2020/21 and 2021/22 (to date)*
- *The number of plots owned by Homes England at the end of the financial years 2016/17, 2017/18, 2018/19, 2019/20, 2020/21 and 2021/22 (to date).*
- *The estimated number of homes that could be built on plots currently owned by Homes England.*
- *The amount of money Homes England has spent in total on estate agent fees, legal fees and consultancy fees associated with purchasing land annually for the financial years 2016/17, 2017/18, 2018/19, 2019/20, 2020/21 and 2021/22 (to date).*

Response

We can inform you that we do hold the information that you have requested. However, to comply with your request would exceed the appropriate limit for the cost of compliance. We therefore rely on section 12, exemption where the cost of compliance exceeds the appropriate limit under the FOIA.

Section 12 - Exemption where cost of compliance exceeds appropriate limit

(1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

(2) Subsection (1) does not exempt the public authority from its obligation to comply with paragraph (a) of section 1(1) unless the estimated cost of complying with that paragraph alone would exceed the appropriate limit.

(3) In subsections (1) and (2) “the appropriate limit” means such amount as may be prescribed, and different amounts may be prescribed in relation to different cases.

(4) The Minister for the Cabinet Office may by regulations provide that, in such circumstances as may be prescribed, where two or more requests for information are made to a public authority:

(a) by one person, or

(b) by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign, the estimated cost of complying with any of the requests is to be taken to be the estimated total cost of complying with all of them.

(5) The Minister for the Cabinet Office may by regulations make provision for the purposes of this section as to the costs to be estimated and as to the manner in which they are to be estimated.

We have considered the current wording of your request and in its current scope we have determined that to establish where all elements of the information is held, to locate the information, retrieving the information and extracting the information would exceed the appropriate limit in terms of timeframes.

Under the terms of the Act we are not obliged to provide any information compiled in the course of our searches prior to concluding section 12 is engaged.

Advice and Assistance

In compliance with the Section 45 Code of Practice (Paragraph 2.10) and to offer advice and assistance under section 16 of the Freedom of Information Act 2000, you may wish to consider narrowing the scope of your request.

We can advise that the section 12 limit is reached particularly due to the request for the “*number of plots owned by Homes England*” and the “*fees associated with purchasing land*”. We hold several documents across multiple internal systems where we would need to locate, retrieve, and extract the required information. Once all the information is located and accumulated it will then need to go through a review process to provide the specific information that has been requested. Additionally, your request for each stated financial year further extends the limit. At this stage it was determined that to comply with your request would exceed the appropriate limit for compliance.

Your request could be refined by limiting the scope of your request (for example, only asking how much money Homes England has spent in total on purchasing land intended for development). Your request can further be refined by specifying a smaller time period for which the information is held, i.e. the 2020 to 2021 financial year only.

Please note that due to the broad scope of your request we cannot confirm that any further request would not also exceed the section 12 cost limit at this time.

Right to Appeal

Your request for review must be made in writing, explain why you wish to appeal, and be received within 40 working days of the date of this response. Failure to meet this criteria may lead to your request being refused.

Upon receipt, your request for review will be passed to an independent party not involved in your original request. We aim to issue a response within 20 working days.

You may also complain to the Information Commissioner's Office (ICO) however, the Information Commissioner does usually expect the internal review procedure to be exhausted in the first instance.
