Thank you for your email of 23 September 2021 to the Ministry of Defence (MOD) requesting the following information:

"Please can you provide a list of service personal who have given their life in service whilst resident in Ash Parish, Surrey, After the 2nd World War.

Hello, I am a Parish Councillor At Ash Parish Council. I wondered if you could help us find the names of service persons who may have died in service since the 2nd world war, whilst resident in Ash Parish. Each year we hold a memorial on Remembrance Sunday, in the past few years, we have asked school children to read out names from the memorial itself for the 1st and 2nd world war. However, we have considered there may be more names to remember not engraved on this memorial, specifically those after these wars. If able to be given to the public, we would like to remember them in future services service.

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and I can confirm that no information in scope of your request is held. This is because a service person's place of residence at the time of their death would normally be the unit, barracks, or theatre in which they were serving, rather than a parish in a community.

Under Section 16 (Advice and Assistance) you may be interested to know that the MOD does hold records of service person's places of birth as listed on their death certificate.

Please let me know if you would be interested in this information and I will be happy to process the request under the FOIA.

If you wish to complain about the handling of your request, or the content of this response, you can request an independent internal review by contacting the Information Rights Compliance team, Ground Floor, MOD Main Building, Whitehall, SW1A 2HB (e-mail CIO-FOI-IR@mod.gov.uk). Please note that any request for an internal review should be made within 40 working days of the date of this response.

If you remain dissatisfied following an internal review, you may raise your complaint directly to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not normally investigate your case until the MOD internal review process has been completed.
