Thank you for your email of 21 June 2021 to the Ministry of Defence (MOD), requesting the following information:

"I am requesting information on the below named soldier under the FoI Act as the person was born over 112 years ago.

I am seeking his service records and full medal entitlement from both World Wars please.

The deceased serviceman's details are as follow:

Samuel Scott HALLIDAY - Royal Artillery.

Born: 4th October 1895 Died: 9th October 1959

Service Numbers: 978, 750157, 741940"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the MOD and I can confirm that all information in scope of your request is held.

Mr Halliday's service records show he served in the Territorial Army (TA) from 26 July 1921 to 04 May 1939 under service number 741940. The medal entitlement of Samuel Scott Halliday is as follows:

- Efficiency Medal (T)
- Coronation Medal
- Military Medal

Furthermore, the records also show that under service number 750157 the medal earner was discharged due to wounds, possibly during WW1 service, and the medal cards can be found at The National Archives at the following link: https://www.nationalarchives.gov.uk/
