PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about invasive alien species permits which APHA received on 02 August 2021. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and our response is detailed below:

- 1. "How many permits have been issued by the Animal and Plant Health Agency under section 35(1)(c) of the The Invasive Alien Species (Enforcement and Permitting) Order 2019?"
 - APHA have not issued any permits under section 35(1)(c) of the Invasive Alien Species Enforcement and Permitting Order.
- 2. "For all those species which were the subject of permits, how many different permits were issued for each species?"
