PROPOSED DOVER HARBOUR OUTER WAVE WALL

NOTICE OF APPLICATION FOR A HARBOUR REVISION ORDER AND MARINE LICENCE

1. NOTICE IS HEREBY GIVEN that Dover Harbour Board ("the applicant") has applied to the Marine Management Organisation ("MMO") for a Harbour Revision Order (HRO) under section 14 of the Harbours Act 1964 ("the Act") and for a marine licence under Part 4 of the Marine and Coastal Access Act 2009.
2. The project would involve the construction of works at Dover Harbour in Kent. In particular, a Wave Wall approximately 70 metres in length is proposed to be constructed in the Outer Harbour to protect the new marina constructed under the powers conferred by the Dover Harbour Revision Order 2012.
3. The MMO determined that the project would not require Environmental Impact Assessment (EIA) under Schedule 3 of the Act. The project was also not considered to require an EIA under the Marine Works (EIA) Regulations 2007. No environmental statement has therefore been supplied by the applicant.
4. A copy of the draft HRO, marine licence application and accompanying supporting documents may be inspected strictly by prior appointment, free of charge, Monday to Friday between the hours of 9:30 a.m. to 5:00 p.m. until the expiry of a 42 day period starting on the date at the foot of this notice, at the offices of Dover Harbour Board at Harbour House, Dover, Kent CT17 9BU.

6. Due to the Coronavirus (COVID-19) pandemic, you should ensure that you follow any Government guidance or restrictions which may currently be in place at the time when inspecting the documents.
7. Due to the Coronavirus (COVID-19) pandemic, rather than inspecting those documents in person, you are encouraged to view and download the documents instead from the respective website addresses specified in paragraphs 8 and 9 below.

12. An objection or representation **should**:

- i. be received before the expiry of a period of 42 days starting with the date at the foot of this notice;
- ii. be made in writing quoting references **HRO/2021/00006 and MLA/2021/00448**;
- iii. state the grounds of the objection or representation;
- iv. indicate who is making the objection or representation; and
- v. give an address to which correspondence relating to the objection or representation may be sent.

13. The MMO will pass to the applicant a copy of any objections and other representations received.

14. Any objections duly made and not withdrawn and any representations duly made will be considered before the MMO makes a determination in respect of the applications. If an objection is duly made and not withdrawn then the MMO may cause an inquiry to be held.
