**The East Anglia One Offshore Wind Farm Order 2014 (as amended) – Application for a Variation to Deemed Marine Licence  
Section 72 of the Marine and Coastal Access Act 2009**

The Marine Management Organisation (MMO) received a request from East Anglia One Limited (EAOL) on 30 March 2021, to vary the Deemed Marine Licence (dML) contained within Schedule 10 of The East Anglia One Offshore Wind Farm Order 2014 (as amended).

The variation request sought a non-material change to the 2014 Order (as amended) and variations to the dML in order to reduce the maximum number of Wind Turbine Generators (WTGs) and certain associated parameters consented under the 2014 Order (as amended) to reflect the number of WTGs and associated parameters installed at East Anglia One Offshore Windfarm.

The MMO has now completed its consideration of this request and, in exercise of the powers conferred by section 72(3)(d) of the Marine and Coastal Access Act 2009, has varied the dML as detailed in the Notice of Variation enclosed (Schedule 10). Also enclosed is a copy of the varied dML.

In accordance with regulation 3 of The Marine Licensing (Notices Appeals) Regulations 2011, you may appeal the notice of variation to the First-tier Tribunal. If you wish to appeal then in accordance with Rule 22(1)(b) of the Tribunal Procedure (First-tier Tribunal)(General Regulatory Chamber) Rules 2009 (SI 2009/1976) you have 28 days from the date of the sending of the notice of variation to send or deliver a notice of appeal to the First-tier Tribunal.
