

PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about cat imports, which APHA received on 10 August 2021. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and our response is detailed below:

"Data recorded:

 What data do you currently collect about cats legally entering the UK under the Pet Travel Scheme? (e.g. age, breed, microchip number, country of origin, if the cat is declawed)

APHA do not hold or record data on cats legally entering the UK under the Pet Travel Scheme. However please see the attached link regarding Pet Travel published on gov.uk, which details the rules on pet travel into Great Britain.

Cats seized:

2. How many cats were seized at the UK border for the years 2020 and 2019?

2019 – 14 cats 2020 – 36 cats

Which countries did the seized cats arrive from in 2020 and 2019?

APHA can confirm the countries were Bulgaria, Germany, Hungary, Latvia, Lithuania, Moldova, Poland, Romania, Russian Federation, Slovakia and the Ukraine.

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

4. What were the reasons that cats were seized in 2020 and 2019?

APHA can advise that when dogs, cats and ferrets have been imported and non-compliances are identified, enforcement action is taken under two different areas of legislation, the Rabies (Importation Of Dogs, Cats and Other Mammals) Order (RIO), and TARP.

The purpose of the Rabies (Importation Of Dogs, Cats and Other Mammals) Order (RIO) is to prevent the spread of rabies by regulating the import of animals. Any animal landed that is not fully compliant with the Pet Travel requirements, the Balai Directive (Council Directive 92/65/EC) or a landing licence issued under the RIO is treated as an illegal import and dealt with by the Local Authority.

The Trade in Animals and Related Products Regulations 2011 (TARP) is the domestic legislation transposed from EU Law. Non-compliance under TARP could include non-notification to the receiving office of an import, absence of or invalid Health Certificate or failure to deliver to the stated destination on the notification.

5. What percentage of those cats seized were sick and needed veterinary treatment in both 2019 and 2020? Please specify what treatment they required if possible.

APHA do not hold this information.

6. How many cats that were seized entering the UK in both 2019 and 2020 were pregnant?

APHA can confirm that no cats were pregnant.

7. How many cats that were seized entering the UK were under six months old in the year 2020 and 2019?

APHA can confirm that 17 cats were under six months old.

Cats entering the UK legally under the Pet Travel Scheme:

8. How many cats that entered the UK legally under the Pet Travel Scheme were pregnant in the year 2020 and 2019?

As with question 1, APHA do not hold or record this information.

9. How many cats that entered the UK legally under the Pet Travel Scheme were under six months old in the year 2020 and 2019?

As with question 1 and 8, APHA do not hold or record this information.
