MCA surveyors and policy teams are actively involved in, the Southampton Boatshow, Seaworks, Skipper Expo International in Aberdeen and Bournemouth providing advice and guidance on maritime legislation.  The above promotions have only taken place where appropriate in light of the ongoing Covid-19 pandemic.
