Dear ████████,

I am writing about your email of 25 October 2021, requesting the following information:

'I would be grateful if you could please supply any information you hold regarding a

Land Rover Defender PE05AA. Could you please include any details from the Merlin system and any other subsequent source i.e. the JAMES system. I have checked your previously released Merlin disclosures but they hold minimal information on this vehicle.'

Your request has been handled in accordance with the Freedom of Information (FOI) Act 2000.

A search has been carried out of Ministry of Defence (MOD) records and it is confirmed that some information is held on your vehicle that can be released. This is enclosed, as follows:

Annex A - Vehicle History (Redacted)
Annex B - Fault History (Redacted)
Annex C - Inspection History
Annex D - Modification History
Annex E - Service History

However, information has been withheld in accordance with exemptions of the FOI Act.

The Vehicle Transfer History (Annex A) contains details about some of the in-service owners of your vehicle, as held on the MOD's Joint Asset Management and Engineering Solutions (JAMES) system. The name of an individual has been redacted in accordance with Section 40 (Personal Information) of the FOI Act. As this is an absolute exemption it was not necessary to determine the balance of interest in releasing or redacting this information.

It has proved necessary to withhold some commercially sensitive information in the Fault History (Annex B) relating to contractor repair times, which has been withheld under qualified exemption Section 43(2) (Commercial Interests). Section 43 concerns information which if disclosed would or would likely prejudice the commercial interests of any person (including defence contractors and the public authority holding it).

As this exemption is qualified, it was necessary to undertake a Public Interest Test to determine whether the balance for withholding the information outweighs that for disclosure. General arguments in favour of release were that full disclosure would demonstrate the MOD's commitment

to openness and transparency; and make the UK Government more accountable to the electorate. The FOI Act also contains a presumption for release.

The Fault History provides details of the time taken by MOD contractors to rectify fault reports on PE05AA. This data, along with previously published information, could be used to make reasonable assumptions about hourly labour rates. As market sensitive information, this could then be exploited by commercial competitors to undercut the contractor when bidding for similar work.

Given the arguments described above, on balance, it was determined that the information should be withheld. The level of prejudice against release of this exempted information has been set at the higher level of “would” rather than “would be likely to”.
