REQUEST FOR INFORMATION – INFORMATION RELATING TO THE ROADSIDE BOMBING AT BALLYDUGGAN ROAD, DOWNPATRICK - FOI 2021/08764

Therefore, all personal information has been redacted.

Dated 09-10 April 1990

Daily Operation Brief - 09 - 10 April 1990

39 Inf Bde

Four soldiers died when an IED detonated under the rear vehicle of a abandoned at the rear of [Redacted], Downpatrick, GR [Redacted], at 090830A and was recovered. At 0655A an RUC patrol had found motorcycle which had been taken after a house takeover at Kileavey Road, Newry GR 079273, at 021830A. The motorcycle was found two vehicle military patrol as it passed over a culvert at GR [Redacted] on the A25 near Downpatrick. After EOD action the device was two boiler suits and a military style boot on the Bonecastle Road, GR [Redacted], approximately 1 km from the seat of the explosion. estimated at 500 kgs of HME. A CW led 250 metres along a stream bed to a Firing Point on high ground at GR [Redacted]. A firing pack and some coils of wire were recovered from the Firing Point. The terrorists are believed to have escaped from the scene on a CWIED/LANDMINE, DOWNPATRICK (3 UDR) 090745A. 1
