Thank you for your email of 09 February in which you requested the following information:

"Under the FOI act, could you provide details of the number of trained service personnel who achieve the lowest possible score on the Army's physical training assessment. Could you also provide details of the number of service personnel who have taken the new physical assessments."

You have since clarified your request on 05 March with following request:

"With regard to your letter of 5 March 2021, I would like to clarify my FOI request. I would like details of the number of soldiers, both regular and reserve, who have taken the Role Fitness Test and the numbers of those who have passed and failed. I would also like details of the number of soldiers, both regular and reserve, who have taken, passed and failed the Annual Fitness Test; I would also like the same figures for those soldiers who have taken the Soldier Condition Review if appropriate. If possible I would also like the figures broken down by, year, rank and sex. I would like figures from 2019 onwards."

Since then, I have wrote to you on 30 April advising that we will not be able to answer your request without exceeding the appropriate limit under s.12(1) and offered the refinement of your request to bring the cost of compliance under the limit. You have since confirmed you wish to proceed with your request under advised refinement on 04 May with following request:

"I would like to refine my FOI request as per your suggestion of 30 April 2021.. I would like details of the number of soldiers, both regular and reserve, who have taken the Role Fitness Test and the numbers of those who have passed and failed. You may also wish to ask for details of the number of soldiers, both regular and reserve, who have taken, passed and failed the Annual Fitness Test. You may additionally ask for the same figures for those soldiers who have taken the Soldier Condition Review; all the figures broken down by year and sex from 2019 to present."

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000. A search for the information has now been completed within the Ministry of Defence, and I can confirm that the information in scope of your request is held and is in the table below. I apologise that it has taken slightly longer to reply than it would normally have done, but hope you will understand this is because of the unusual circumstances in which we are currently working.

Notes/Caveats to the table:

- 1. This data has been provided from a single service source rather than official statistics produced by Defence Statistics as they do not collate this information.
- 2. Figures have been rounded to 10 to limit disclosure and ensure confidentiality; numbers ending in "5" have been rounded to the nearest multiple of 20 to prevent systematic bias.

- 3. Totals and sub-totals have been rounded separately and so may not appear to be the sum of their parts.
- 4. "-" denotes zero or rounded to zero.

Additionally, the following caveats must be noted:

- Covid-19 has significantly impacted on the ability of the British Army to conduct mandated fitness testing.
- Annual Fitness Test (AFT)/Role Fitness Testing (Soldier) (RFT(S)) testing has been suspended for the majority of 2020 and all of 2021 (as of 31 Mar 21). It was only undertaken by personnel warned for Operations, on High Readiness and other essential military activities only.
- Regular and Reserve personnel in non-deployable HQ/units are not required to undertake RFT(S) and AFT.
- Soldier Conditioning Review was introduced on 1 Apr 19 as a diagnostic tool to assess the components of physical fitness. Covid-19 has significantly impacted the use of this gym based assessment due to Force Health Protection Instruction requirements; with the Army suspending its use during periods of the pandemic.
- Ground Close Combat (GCC) personnel commenced new Role Fitness Test (Soldier) from the 1 Apr 19. The AFT ceased for this cohort at that time. Non-GCC continued to be assessed using the AFT, with the transition to RFT(S) commencing as of 1 Apr 21.
- Results are displayed by calendar year (as requested), however, the Army normally has a 12 or 6 month rolling currency for testing and assessments.
