A search for information has now been completed by the Ministry of Defence Police and I can confirm that we do hold information in scope of your request.

Please list all training and learning and development that you were scheduled to ordinarily deliver to police officers and staff that were completely cancelled as a result of the guidelines regarding safe working during the COVID-19 pandemic (please include all courses i.e. from recuit training to detective training)

Training that was delivered prior to the COVID 19 Pandemic was paused as opposed to cancelled as advised by the National Police Chiefs Council (NPCC) and the College of Policing.

# From this list of courses please list those that continued, but were moved to an online delivery as a result of the guidelines regarding safe working during the COVID-19 pandemic (please include all courses i.e. from recuit training to detective training)

The Ministry of Defence Police did not fully move courses to online digital delivery. Elearning/MS teams and Skype supported the Recruit Training Programme if officers had to self-isolate.

Please list or indicate which of the above courses were what mandatory (including refreshers) courses, that were cancelled i.e. defensive tactics training, police fitness tests, firearms training

Training was paused (see above) and qualifications were extended.

### Approximately how many police staff does this affect?

Mandatory training for civilian staff is completed online through MOD provided resources such as Civil Service Learning.

### Approximately how many police officers does this affect?

1221 Police officers had their Personal Safety Training qualification extended 1320 Police Officers had their Multi Stage Fitness Test qualification extended

## For cancelled mandatory courses, what was the organisations response to certification i.e. extended, allowed to expire etc.

Courses were paused not cancelled and qualification extended.

# Did you use any alternate approach to training and learning and development beyond moving online?

Yes

#### If, so, what approach was used?

The number of students on some courses was reduced. The number of students attending the Standard response driving training was reduced from three to two students. This was as a contingency due to close contact within vehicles, in addition to PPE. The Ministry of Defence Police delivered Scottish Recruit training in Scotland at an alternative location which was non-residential. Personal Safety training used video to support learning and to reduce close contact time with students, evidencing competence was another method used in Personal Safety Training to reduce close proximity in practical scenarios.
