**SCREENING DIRECTION CONFIRMING THAT AN ENVIRONMENTAL IMPACT  
ASSESSMENT IS NOT REQUIRED**

**CALLANISH FIELD - INCREASE IN PRODUCTION**

**PR/2162/0 (Version 3)**

Whereas CHRYSAOR (U.K.) BRITANNIA LIMITED has made an application dated 25th November 2021, under The Offshore Oil and Gas Exploration, Production, Unloading and Storage (Environmental Impact Assessment) Regulations 2020, and whereas the Secretary of State has considered the application and is satisfied that the project is not likely to have a significant effect on the environment; in exercise of the powers available under regulation 6, the Secretary of State hereby directs that the application for consent in respect of the project need not be accompanied by an Environmental Impact Assessment, provided that the project is carried out as described in the application for the screening direction and in accordance with the conditions specified in the attached schedule.

In giving a screening direction under regulation 6 of the above Regulations, the Secretary of State accordingly gives his agreement to the Oil and Gas Authority to the grant of consent for the project as detailed in the application 33-21.

## **THE OFFSHORE OIL AND GAS EXPLORATION, PRODUCTION, UNLOADING AND STORAGE (ENVIRONMENTAL IMPACT ASSESSMENT) REGULATIONS 2020**

### **SCHEDULE OF SCREENING DIRECTION CONDITIONS**

The grant of this screening direction is conditional upon the screening direction holder complying with the following conditions.

#### **1 Screening direction validity**

This screening direction shall be valid from 1 January 2022.

#### **2 Change to production level(s)**

The holder of the screening direction shall ensure that the change in the level(s) of production do not exceed the amended level(s) detailed in the application for the screening direction, and in the application for consent relating to the approval for the getting of petroleum issued under the relevant production licence Model Clause.

#### **3 Prevention of pollution**

The holder of the screening direction must ensure that appropriate measures are taken to minimise discharges, emissions and waste, in particular through the appropriate use of technology; and to ensure that necessary measures are taken to prevent incidents affecting the environment or, where they occur, to limit their consequences in relation to the environment.

#### **4 Inspections**

Should the Department consider it necessary or expedient for an inspector appointed by the Secretary of State to investigate whether the conditions of the screening direction are being complied with, the holder of the screening direction shall afford the inspector with such facilities and assistance as the inspector considers necessary to exercise the powers conferred by the regulations. The holder of the screening direction shall additionally ensure that copies (electronic or paper) of the screening direction and any other relevant documents are available for inspection by the inspector at:

- a) the premises of the holder of the screening direction; and
- b) the facilities undertaking the project covered by the screening direction.

#### **5 Check monitoring**

Should the Department consider it necessary or expedient to undertake an independent monitoring programme to assess the impact of the project covered by the screening direction, the screening direction holder shall afford the Department



with such facilities and assistance as the Department considers necessary to undertake the work.

## **6 Atmospheric emissions returns**

Following completion of the project covered by the screening direction, the holder of the screening direction shall report all relevant atmospheric emissions, such as combustion emissions, using the appropriate Environmental Emissions Monitoring System (EEMS) reporting forms.

## **7 Unauthorised deposits**

Following completion of the project covered by the screening direction, the holder of the screening direction shall recover any materials accidentally or temporarily deposited on the seabed, such as debris, temporary containers, structures or deposits, or scientific instruments, and shall return the materials to land. If it is not possible to recover any of these deposits, full details of the materials remaining on the seabed must be reported to the Department in accordance with the requirements of Petroleum Operations Notice No.2 (PON2).

## **8 Screening direction variation**

In the event that the holder of the screening direction proposes changes to any of the particulars detailed in the application for a screening direction, the holder must notify the Department immediately and submit an application for a post screening direction amendment. The post screening direction must be in place prior to the amended proposals taking effect.

## **SCHEDULE OF SCREENING DIRECTION DECISION REASONS**

The Secretary of State has decided that, based on the information provided, the project is not likely to have a significant effect on the environment. The main reasons for this decision are:

### **1) Decision reasons**

The following provides a summary of the assessments undertaken by OPRED to determine whether an Environmental Impact Assessment is required for this project, summarises the information considered, the potential impacts and sets out the main reasons for the decision made. In considering whether an Environmental Impact Assessment is required or not, the following have been taken into account:

- a) the information provided by the developer;
- b) the matters listed in Schedule 5 of The Offshore Oil and Gas Exploration, Production, Unloading and Storage (Environmental Impact Assessment Regulations 2020) (the Regulations);
- c) the results of any preliminary verifications or assessments of the effects on the environment of the project; and
- d) any conditions that the Secretary of State may attach to the agreement to the grant of consent.

### **Characteristics of the Project**

Having regard, in particular, to the matters identified at paragraphs 1(a) to (g) of Schedule 5 to the Regulations, the characteristics of the project include the following:-

### **Summary of the Project**

Increase in oil production from the Callanish field for 2022.

### **Description of the Project**

The Callanish field is located in the Central North Sea and produces through the Britannia installation, which comprises the Britannia platform and the Britannia Bridge-Linked Platform (BLP).

The project consists of an increase in oil production of less than 500 tonnes per day from the Callanish field. This increase is due to the new F5 well having been brought online in 2021. There is no corresponding increase in gas production.

No cumulative impacts are expected to occur with any other existing or approved projects.



Pollution and nuisances are restricted to a potential increase in emissions and marine discharges following increased throughput of oil.

There is no change to the assessment of a major accident. The Developer has control measures in place to reduce the risk of a major accident occurring and the probability of such an event occurring is very low.

The project is not at risk from natural disasters given its location in UK offshore waters.

There is not considered to be any significant risk to human health.

### **Location of the Project**

Having regard, in particular, to the matters identified at paragraphs 2(a) to (c) of Schedule 5 to the Regulations, the environmental sensitivity of geographical areas likely to be affected by the project has been considered as follows:-

The Callanish field is located in Block 16/26 of the Central North Sea, approximately 210 km from the Scottish coastline and approximately 45 km from the UK / Norway boundary line, in a water depth of approximately 137 metres.

The surface current speed in the area is approximately 0.2 m/s and the wave height ranges from 2.1 - 2.4 m. Site-specific surveys found the sediment to be relatively uniform in nature comprising poorly sorted medium silt. Soils were interpreted as sandy clay overlying very soft silty clay. The wider Britannia area is known for the presence of pockmarks, where the sediments showed an elevated proportion of fines. None of the pockmarks observed by the site-specific surveys indicated the Annex I habitat methane-derived authigenic carbonate. Levels of hydrocarbons within the sediments were elevated compared to background levels in the CNS, thought to be due to historic nearby wells. The faunal composition identified by the site surveys was dominated by species characteristic of this type of silty/sandy sediment in the CNS. Ocean quahog juvenile specimens were present during sampling. The presence of sea pens and faunal burrows indicated the potential for the presence of the OSPAR-listed habitat 'Seapens and burrowing megafauna communities'.

The project is not located in any protected areas. The closest protected area is the Scanner Pockmark Special Area of Conservation approximately 30 km to the northwest. The project is located in an area of extensive oil and gas development. There are no wrecks or telecommunication cables in the area and the project is not located within an area of military activity.

The project relates to the year 2022 and will overlap with spawning seasons for cod, mackerel, Norway pout and Norway lobster, and is located within the nursery area of several fish species. Several cetacean species have been recorded in the vicinity of the project location. Seabird abundance is low throughout the year, except November and December for which there was no data. The area is described as a low intensity





fishing area.

Given the location of the project, the areas identified at paragraphs 2(c)(i), (iii), (iv), (vi), (vii) and (viii) of Schedule 5 are not likely to be affected by the project.

### **Type and characteristics of the potential impact**

In accordance with paragraph 3 of Schedule 5 to the Regulations, the likely significant effects of the project on the environment have been considered. Potential effects of atmospheric emissions and marine discharges on the environment from the activities associated with the project were assessed. Other than the matters considered further below, there is not likely to be any significant impact of the project on population and human health.

There are no additional power requirements anticipated at the Britannia platform as a result of the increase in production of oil. Any increase in atmospheric emissions is not expected to be significant, as the increase is expected to utilise existing ullage in the Britannia processing plant. Atmospheric emissions are expected to result in a short-term deterioration in air quality in the immediate area. This localised effect is expected to be temporary given the meteorological conditions at the offshore location. The impacts arising from atmospheric emissions on local air quality and climate are not considered to be significant.

It is anticipated that the production increase will not result in any change to current oil in water content of the produced water discharge. No changes to chemical types or quantities are expected as a result of the production increase. The marine environment is expected to rapidly disperse and dilute chemical discharges.

The project does not involve any physical interaction with the sea or seabed and as such no physical impacts on receptors are anticipated.

There is no change to the assessment of a major accident. The Developer has control measures in place to reduce the risk of a major accident occurring, including an emergency response plan, and the probability of such an event occurring is very low. The existing accidental event spill modelling is applicable and no significant impact would be likely to occur from any such event.

There are no expected transboundary impacts as a result of the project and no cumulative impacts have been identified.

### **Decision**

Taking the above considerations into account, the Secretary of State has concluded that the project is not likely to have a significant impact on the environment and that an environmental impact assessment is not required.
