Thank you for your e-mail of the 3 November 2020 requesting the following information:

Under the Freedom of information act 2000, I am requesting the following information:

1. How many females have applied for Pilot in the past three years in the RAF.

2. How many females have been successful in their application to join the RAF as pilot in the past three years.

3. How many operational female pilots are there in the RAF.

4. What is the average current holding time for a personnel who has completed IOT waiting to commence pilot training?

5. What are the eyesight requirements for the role of RAF pilot?

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA). A search for the information has now been completed and I can confirm that information in scope of your request is held.

Question 1 and 2

There are currently 87 trained female pilots in the Royal Air Force.

Question 4

The current holding time for a person who has completed Initial Officer training and is waiting to commence Elementary Flying Training is 72 weeks.

Section 16 (Advice and Assistance) it may be helpful for you to know that holds in the flying training pipeline are not unusual. There have always been planned holds in the flying training

pipeline to ensure all courses are fully utilised. Most trainee pilots will experience a hold at the start of their career before commencing flying training. However, the time that student pilots are waiting to commence their pre elementary flying training is steadily decreasing. Waiting times are forecast to reach agreed Ministry of Defence levels by August 2021.
