This **GENERAL VESTING DECLARATION** is executed on by the Secretary of State for Transport ("the Acquiring Authority").

WHEREAS:

- (1) On 7 June 2018 an Order entitled The High Speed Rail (London-West Midlands) (Greatmoor Railway Sidings Etc.) Order 2018 ("the Order") was made by the Secretary of State for Transport under the powers conferred on the Secretary of State for Transport by the Transport and Works Act 1992 authorising the Acquiring Authority to acquire the land specified in the Schedule hereto.
- (2) Notice of the Secretary of State for Transport's determination to make the Order was published by the Secretary of State for Transport in accordance with sections 14(1)(b), (2A), (3A) and (3AA) of the Transport and Works Act 1992 on 19 April 2018.
- (3) Article 9(1) of the Order provides that the Compulsory Purchase (Vesting Declarations) Act 1981 ("the Act") shall apply as if the Order were a compulsory purchase order and article 9(2) of the Order provides that the Act shall have effect subject to modifications.
- (4) Notice of the effect of the making of the Order was served by High Speed Two (HS2) Limited as Agent for and on behalf of the Acquiring Authority in accordance with section 14A of the Transport and Works Act 1992 on 22 June 2018.
- (5) The notice referred to in (4) above included the particulars specified in section 14A of the Transport and Works Act 1992.

NOW THIS DEED WITNESSETH that, in exercise of the powers conferred on it by section 4 of the Act, the Acquiring Authority hereby declares:-

 The land described in the Schedule hereto (being part of the land authorised to be acquired by the Order) and more particularly delineated and shown coloured pink on the plan annexed hereto, together with the right to enter upon and take possession of the land, shall vest in the Acquiring Authority as from the end of the period of 3 months from the date on which the service of notices required by section 6 of the Act is completed.

For the purposes of Section 2(2) of the Act, the specified period in relation to the land comprised in this declaration is one year and one day.
