## **REMEDY JUDGMENT**

- 1. The respondent is ordered to pay the claimant the sum of £4,573.90 in respect of her wrongful dismissal claim.
- 2. The respondent is ordered to pay the claimant the sum of £91.48 in respect of her accrued unpaid holiday claim.
- 3. The respondent is ordered to pay the claimant compensation in respect of her unfair dismissal claim in the following respects: –

1

- 3.1 the basic award in the sum of £5,715;
- 3.2 the compensatory award in the sum of £8,553.34; that

- 3.3 pension loss in the sum of £526.24.
- 4. The grand total sum ordered to be paid by the respondent subject to the Recoupment provisions is £19,459.96.
- 5. <u>Recruitment provisions</u>
  - 5.1 Monetary award: £19,459.96.
  - 5.2 Prescribed element: £9,503.71.
  - 5.3 Prescribed period: 5 January 2019 to 6 April 2021
  - 5.4 Excess of 5.1 over 5.2: £9956.25.
