### RE: Request for Information – RFI3702

Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

*First request - when sub-contracting display material for pre-application consultations what standards, if any, do you require you contractors to meet with regard to legends/keys for maps, diagrams, plans?* 

Second request - on display board 5 of your Homestead Link consultation what are the colours brown and blue in diagrams 1,2,3,4 and 5 intended to represent (if anything)?

#### **Response**

We can confirm that we do hold some of the requested information. We will address each of your questions in turn.

# First request - when sub-contracting display material for pre-application consultations what standards, if any, do you require you contractors to meet with regard to legends/keys for maps, diagrams, plans?

We can confirm that there are no specified standards for display materials for pre-applications. The Project Team considered that the level of information identified on the boards was appropriate for the consultation exercise. However, feedback highlighted at the consultation event identified the need to provide further clarity on the drawings in respect of road names. These have been updated and the updated consultation boards can be found on the online consultation portal via the following link: <u>HLR Virtual Exhibition (holobuilder.com)</u>.

# Second request - on display board 5 of your Homestead Link consultation what are the colours brown and blue in diagrams 1,2,3,4 and 5 intended to represent (if anything)?

We can advise that the highway drawings need to be read together with the other supporting information on the boards. The brown colour represents the footpath, and the blue represents the cycleway. This is identified on the Road Design Standards cross section and the supporting text on Board No. 4. An additional key was added to Board No. 5 to these drawings for greater clarity.
