PROVISION OF REQUESTED INFORMATION

Thank you for your request for information about fish farm inspections which APHA received on 20 October 2021. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"I understand that the APHA oversees the welfare of farmed fish on behalf of Scottish Ministers.

I am told that fully trained inspectors carry out routine visits to fish farms and respond to any complaints about fish welfare.

Can you please tell me

a. how many of your inspectors cover Scotland?

There are currently 6 APHA fish welfare trained veterinary inspectors in Scotland.

b. how many inspection visits to Scottish fish farms were carried out by them for each of the last 5 years?

2017 - 2 visits

- 2018 3 Visits
- 2019 9 visits
- 2020 7 visits
- 2021 6 visits done as of the 20th October 2021

c. how many fish welfare complaints in Scotland were handled by APHA for each of the last 5 years?"

APHA is an Executive Agency of the Department for Environment, Food and Rural Affairs and also works on behalf of the Scottish Government, Welsh Government and Food Standards Agency to safeguard animal and plant health for the benefit of people, the environment and the economy.

The number of complaints that have been investigated by APHA is broken down below, all complaints received by APHA are fully investigated although some may not be assessed as requiring a physical visit:

- 2017 no complaints
- 2018 6 complaints investigated (two complaints duplicated)
- 2019 13 complaints investigated (one complaint duplicated)
- 2020 5 complaints investigated
- 2021 11 complaints investigated as of the 20th October

It may help in your request to explain APHA's role in fish inspections.

The Animal and Plant Health Agency (APHA) are responsible for investigating allegations relating to the welfare of farmed fish. We take all reports of animal welfare concerns seriously and investigate them.

Scottish Government Fish health inspectors are appointed by the Scottish Ministers to act as inspectors under the aquaculture and aquatic animal health regulations and will refer any concerns on fish welfare to APHA for consideration
