REQUEST FOR INFORMATION: Behavioural Insights Team

Thank you for your request for information of 13 January 2022 about Behavioural Insights Team. We have handled your request under the Freedom of Information Act 2000 (FOIA).

Your information request and our response are set out below.

I am writing to request information regarding this Department's work with the Behavioural Insights Team (BIT) between January 2014 and January 2022. Specifically, I would like access to;

- a list of contracts awarded to the BIT showing the nature of the services provided;
- the approximate value of each contract;
- payments in each financial year to date under each contract;
- total payments to the BIT each year if different to the sum of the amounts above and;
- information on how each contract was awarded including where it was advertised.

In response to this request, the table attached at Annex C outlines the value of each contract and payments made to the Behavioural Insights Team between January 2014 and January 2022.

To note:

- This response is on behalf of the Ministerial Department for Environment, Food and Rural Affairs (Defra).
- Financial years are presented as requested although these do not align exactly with the requested period of January 2014 and January 2022. Our data therefore covers April 2014 to the current position in January 2022. There were no contracts or payments made during Jan-Mar 2014.
- The answers pertain specifically to contracts between Defra and the trading name of Behavioural Insights Ltd.

Information disclosed in response to this FOIA request is releasable to the public. In keeping with the spirit and effect of the FOIA and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on <u>GOV.UK</u>, together with



any related information that will provide a key to its wider context. No information identifying you will be placed on the GOV.UK website.
