Thank you for your email of 19 January 2022 to the Ministry of Defence (MOD), requesting the following information:

*"I would like to know if Veterans UK medical advisors, involved in Armed Forces Compensations Scheme (AFCS) cases with Post Traumatic Stress Disorder (PTSD) as the injury, hold professional qualifications such as PsychD and are members of a professional institute such as the British Psychological Society".*

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that some information in scope of your request is held. The recorded information which relates to the information you have requested can be found at Annex A below. However, whilst we hold a list of the qualifications held by all the MAs working in Veterans UK, we do not hold details relating to what associations or institutes that they are members of.
