JUDGMENT OF THE EMPLOYMENT TRIBUNAL

25 Upon both parties having now agreed terms for this Judgment, of consent, as per their representatives' correspondence to the Tribunal dated 2 and 3 October 2018, and the Employment Judge, acting in terms of Rule 64 of the Employment Tribunal Rules of Procedure 2013, considering it fit to make such a Judgment, of consent of both parties, and with the agreement of the respondents' liquidator, as 30 per correspondence of 27 September 2018 to the Tribunal, confirming the liquidators' intention not to defend the matter, notwithstanding the ET3 response lodged on 30 May 2018, with letter of 24 May 2018 from Richard Gardiner, liquidator, making written representations, thejudgmentof the Employment Tribunal is that:

- The claimants were employed by the respondents, AL Gordon Engineering Ltd in various posts. Various descriptions of employees were made redundant.
- On 9 January 2018, the claimants, and all employees, were dismissed by the respondents, by way of redundancy. On 8 January 2018, solicitors were instructed to present the Petition to wind up the company, which was submitted on 9 January 2018. Employees were advised of the position on that date and told to go home and await the Provisional Liquidator's appointment.
- 3. Provisional Liquidator was appointed on 11th January 2018 and the winding up Order/Interim Liquidator appointment was made on 7 February 2018.
 - 4. The respondents did not inform and consult with the claimants in terms of s.188 and S.188A of The Trade Union and Labour Relations (Consolidation) Act 1992.
 - 5. The claimants will be awarded 8 week's pay for the protected period, which runs from 9th January 2018, being a protective award in terms of s.189(2) of The Trade Union and Labour Relations (Consolidation) Act 1992.
