RE: Request for Information – RFI3749

Thank you for your request for information which was processed in accordance with the Freedom of Information Act 2000 (FOIA).

You requested the following information:

One thing we're interested in is the ethnic identities of those purchasing a home through the scheme. I note from a [gov.uk](#) press release of 16.11.20 that "A quarter of first time buyers who have bought with the scheme are from black, Asian and minority ethnic backgrounds", but I haven't been able to find the data-set this is based on. It would also be very helpful to have a link to this and any updated stats. on the ethnic identities of people purchasing through Help to Buy.

Response

We can inform you that we do hold the information that you have requested. However, to comply with your request would exceed the appropriate limit for the cost of compliance. We therefore rely on section 12, exemption where the cost of compliance exceeds the appropriate limit under the FOIA.

Section 12 - Exemption where cost of compliance exceeds appropriate limit

(1) Section 1(1) does not oblige a public authority to comply with a request for information if the authority estimates that the cost of complying with the request would exceed the appropriate limit.

(2) Subsection (1) does not exempt the public authority from its obligation to comply with paragraph (a) of section 1(1) unless the estimated cost of complying with that paragraph alone would exceed the appropriate limit.

(3) In subsections (1) and (2) "the appropriate limit" means such amount as may be prescribed, and different amounts may be prescribed in relation to different cases.

(4) The Minister for the Cabinet Office may by regulations provide that, in such circumstances as may be prescribed, where two or more requests for information are made to a public authority:

(a) by one person, or

(b) by different persons who appear to the public authority to be acting in concert or in pursuance of a campaign, the estimated cost of complying with any of the requests is to be taken to be the estimated total cost of complying with all of them.

(5) The Minister for the Cabinet Office may by regulations make provision for the purposes of this section as to the costs to be estimated and as to the manner in which they are to be estimated.

We have considered the current wording of your request and in its current scope we have determined that to establish where all elements of the information is held, to locate the information, retrieving the information and extracting the information would exceed the appropriate limit in terms of timeframes.

Under the terms of the FOIA we are not obliged to provide any information compiled in the course of our searches prior to concluding section 12 is engaged.

Advice and Assistance

In compliance with the Section 45 Code of Practice (Paragraph 2.10) and to offer advice and assistance under section 16 of the Freedom of Information Act 2000, you may wish to consider narrowing the scope of your request.

We can advise that the cost limit is reached particularly due to the request for "*stats. on the ethnic identities of people purchasing through Help to Buy.*". We proceeded to work with the responsible Information Owners for this request to determine what information was held. This information is not already collated as part of our engagement with Help to Buy customers. Therefore, to collate the information you are seeking, we would have to manually filter through every Help to Buy customers application to determine ethnicity. Further to this, we can advise that this specific type of data is voluntary by the applicant therefore, if this data were to be reported on, it would not be a complete reflection.

At this stage it was determined that to comply with your request would exceed the appropriate limit for compliance.

You could refine your request to be under the cost limit by requesting information for specific geographical areas or specifying a smaller time period for the information. However, please note that due to the broad scope of your request, we cannot confirm that any further request would not also exceed the section 12 cost limit.

Right to Appeal

If you are not happy with the information that has been provided or the way in which your request has been handled, you may request an internal review. You can request an internal review by writing to Homes England via the details below, quoting the reference number at the top of this letter.
