This letter confirms the amount of delegated Adult Education Budget (AEB) you will receive in the financial year (FY) 2022-23 (1 April 2022 to 31 March 2023) to deliver relevant adult education functions in your delegated area.

#### Payment arrangements

Your total devolved AEB for FY 2022-23 is set out in the table in Annex A and will be paid by mid-April 2022.

We are providing this grant as a non-ring-fenced transfer under Section 39A of the Greater London Authority Act 1999 and have copied this grant letter to the Chief Finance Officer of the Greater London Authority for information.

### Assurance arrangements

The delegation letter<sup>1</sup> agreed between you and the Secretary of State sets out what assurances should be in place when carrying out the adult education functions.

The Department for Education also has an associated memorandum of understanding<sup>2</sup> in place with you in relation to the devolution of adult education
