Converter Academy Orders

Points discussed in relation to school conversion.

Project: Discussion to consider Kaye's First and Nursery School, Kirklees, to convert and join Learning Accord Multi-Academy Trust

AB discussion:

- The board agreed that the proposal is both sensible and works well geographically
- The board were also reassured by the trust's School Improvement strategy
- The board have suggested that the trust will need to review and expand their expertise as the trust grows
- SRMA to be deployed to continue reviewing the trust's financial needs, specifically focusing on their growth strategy

RSC decision: Approved.

Further actions required: Project lead to inform Trust and DCS of decision

Project: Discussion to consider All Saints Church of England Primary School, Bradford, to convert and join Collaborative Learning Trust

AB discussion:

- The board agreed that this is a sensible proposal but shared concerns regarding the location of the school
- The board also shared concerns regarding the trust's rate of growth
- The board identified expertise gaps within the trust's central team, with specific observation that there are no members who can provide challenge on the trust's educational strategy
- SRMA to be deployed
- The board suggested that the trust apply discipline on future growth and focus on the patch created with existing schools

RSC decision: Approved with conditions.

Project: Discussion to review sponsor options for Castle View Primary School, Lancashire

Reason for Academy Order: Ofsted Category 4

AB discussion:

- The board discussed the representations received in response to this project and the concerns raised
- The board also shared concerns about the need for a variety of trusts within this area. Despite this, the board agreed that the trust is at lower risk financially and have a good track record of improving schools
- The board suggested that this could be used as a transition for Cidari to become a mixed MAT
