- The board recognised how educational leaders in the Wakefield area have worked collaboratively to strengthen the trust network and its impact within the sub-region over recent years.
- The board also acknowledged the opportunities the proposed sponsor could bring to this school based on previous track record and the specific needs of the school, including its EAL cohort. They also recognised the strategic sense given the proximity of the primary school to the trust.
- The board discussed further opportunities for local MATs in the area to grow.
- The board agreed to the following actions before the project could be approved (all are now completed):
  - RSC to attend a meeting with Outwood Grange Academies Trust to discuss the representation and gain further clarity in terms of their engagement with local MATs.
  - RSC to attend a meeting with the correspondent.
