Description – identifies the total compulsory time pupils spend in school, in a typical 5 day week (including breaks, from the start of the compulsory day, e.g. morning registration, to the end of the compulsory day, e.g. home time)

Type and format – 99.99

Code set / Valid values: Any amount greater than 0.00, recorded to 2 decimal places

Item level validation - N/A

Implementation date:

This data item is to be collected from the Spring 2023 school census however, is requested to be in systems from the start of the 2022 to 2023 academic year to allow schools to enter data in preparation.

Reason for change (including benefits)

Evidence from the pandemic has shown us that cumulative time in school matters for the breadth and quality of education. We know some pupils are receiving less time than others and over time this will have a cumulative negative impact on learning and cause disparity in pupil outcomes.

The SoS has asked us to include in the Schools White Paper an expectation that schools should meet a minimum school week of 32.5 hours from September 2022, with some flexibility for non-mainstream settings such as special schools and AP providers. This will be supported by non-statutory guidance, with targeted support for schools that do not meet the expectation.

Impact of not doing the change

We would not have a robust dataset on time in schools that can be used for policy development and potentially be used to identify schools who are not meeting the expected minimum of a 32.5 hour school week (being implemented from September 2022) to offer targeted support.

Section 2 - impact analysis

Software suppliers' summary of impact assessment

Supplier 1:

• It would be good to confirm this value would be highlighted in the summary output to help provide a 'call to action' for the school to check/update this value

The department confirms this forms part of the spring 2023 school summary.

- You could consider the maximum resolution required for this, e.g. 15 mins, instead of giving the full flexibility of 2 decimal places, this could enable slightly easier entry as we could display a dropdown of X minute intervals instead of allowing free-form entry that might not easily align with a number of minutes, or be more easily confused with minutes instead of a fraction of an hour.
- Regardless of the above 2 this is broadly fine, but the summary output feels pretty important to me.

Supplier 2:

- We are not able to calculate the school time so it will be a new data item where the time can be recorded as hours expressed as 99.99.
- We will consider adding a query if the school enters less than 32.50 hours (ie not 32 hours and 30 minutes) which is the expected minimum hours in a normal school week.
- We cannot promise to include this new data item that is non statutory in our Summer release, but we will definitely include it in our Autumn 2022 release ready for school census Spring 2023.
