

Thank you for your email of 9 August 2021 requesting the following information:

"We have been anecdotally informed that the MOD have a regulation that if a textile item touches skin it can not be reused by another person - is that accurate and if so could you share with us the details of that policy?

Does the MOD track how many tons of textile waste it produces each year, and if so could you inform us of the numbers?"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that some information falling within the scope of your request is held. This is provided, as follows:

We have been anecdotally informed that the MOD have a regulation that if a textile item touches skin it can not be reused by another person - is that accurate and if so could you share with us the details of that policy? Next to Skin Items are defined as socks, underwear, thermal underwear, vests, T-shirts, uniform shirts, hats and towels. These items are classed as unserviceable once they are no longer of use, either because they are worn out or because the wearer has no further need for them; for example, after leaving service. Any item declared as unserviceable is returned to depot for disposal.

**Does the MOD track how many tons of textile waste it produces each year, and if so could you inform us of the numbers?** As previously advised to another individual in your company in our FOI response Ref FOI2021/08660 dated 18 August 2021, a new contract for the disposal of clothing/textiles has been awarded to Field Textiles Limited. Under the terms of this new contract agreement there is no requirement for the contractor to provide the MOD with details of the weight of the clothing/textiles it disposes of. Therefore, the information you have requested is not held.
