Thank you for your freedom of information requests received on 6 September 2021. As both requests relate to the cost of home working equipment, we have answered both below.

You asked:

- Please send me the total costs for home working equipment for officials in your department since March 2020.
- Please send me a list of all items for home working in your department since March 2020 which cost more than £1,000.

In response to your requests I can advise:

- The SSRO has spent £7,007.30 on equipment to be used whilst working from home since March 2020. All equipment has been purchased in the SSRO's name and will be returned to the office as working from home ends.
- The SSRO has not purchased any individual items over £1,000.00 for home to work use since March 2020.
