Thank you for your request for information about Movement Assistance Scheme for horses, which APHA received on 07 January 2022. Your request has been handled under the Freedom of Information Act (FOIA) 2000.

The information you requested and the response is detailed below:

"We are requesting under the **Freedom of information Act** information on the current usage of the Movement Assistance Scheme for <u>horses</u> shipping from GB to Northern Ireland.

We are requesting a monthly breakdown since 1st January 2021 to December 2021 of total costs paid direct to OV vets under this scheme. (I appreciate there may be a lag for December)"
