**REQUEST FOR INFORMATION – INFORMATION RELATING TO THE BOMBING OF THE MOUNTAINVIEW TAVERN, BELFAST ON 5 APRIL 1975**

I can confirm that your request has been considered under the provisions of the Freedom of Information Act 2000 (FOI (A)), and the process is now complete.

You stated the following:

***“I wish to request copies of the following hard copy documents in relation to the bombing of the Mountainview Tavern on 5 April 1975 in Belfast, in which five persons were killed.***

***The following reports are requested:***

- \* Unit Incident Report (Increp) issued by Battalion HQ 7 UDR and 10 UDR;***
- \*ATO request for the clearance of the site;***
- \*NI Report covering the period of his killing;***
- \*Weapons Intelligence Report collated by personnel from 39 Inf Bde Weapons Intelligence Section;***
- \*Serious Incident Report covering the whole incident from Initial Report to final clearance;***
- \*Any other document held in connection with this incident”***

I can confirm that the MOD holds some information relating to your request. This information has been located in a range of documents and relevant extracts of these have been provided at Annex A. Also attached at Annex B is an IED Report and at Annex C, 2 RMP TAC log sheets. Please note that all information that is redacted using a black box represents information that has been redacted under a Freedom of Information exemption.

Some of the information you have requested could be exempt under Section 23(1) of the Freedom of Information Act, which relates to the bodies dealing with security matters, although it is also possible that the information relates to none of the bodies dealing with security matters. Sections 23(1) and 24(1) are being cited in the alternative as it is not

appropriate, in the circumstances of the case, to say which of the two exemptions is actually engaged so as not to undermine national security or reveal the extent of any involvement, or not, of the bodies dealing with security matters. Section 23 is an absolute exemption and, if it were engaged in this material, the MOD would not be required to consider whether the public interest favours disclosure of this information.

Any information that is not exempt from disclosure under Section 23(1) could be exempt under Section 24(1) of the FOI(A), which exempts information from disclosure if its exemption is required for the purpose of safeguarding national security. We cannot say which of the two exemptions is actually engaged, but to the extent that S24(1) might be engaged. We acknowledge the public interest in openness and transparency, but we consider that there is a stronger public interest in protecting national security.

Some of the information falls within the scope of Section 26 (Defence) of the FOI(A) as its release would or would be likely to prejudice the capability, effectiveness or security of any relevant forces. Section 26 is a qualified exemption and we have conducted a public interest test to determine whether the information should be released or withheld. The factors for this public interest have determined that whilst disclosure would demonstrate openness and transparency this is outweighed by the detrimental effect disclosure would have in revealing the capabilities of military operational planning by compromising the methodologies and practices employed in the gathering and analysis of information. I have therefore concluded that the public interest supports withholding some information under Section 26.

Some of the information falls within the scope of Section 38 (Health and Safety) of the FOI(A), as its release could endanger the physical or mental health of any individual or endanger the safety of any individual.

Section 38 (Health and Safety) is a qualified exemption and we have conducted a public interest test to determine whether the information should be released or withheld. The factors for this public interest have determined that whilst disclosure would demonstrate openness and transparency this is outweighed by the detrimental effect disclosure could have on those mentioned in the documents, or their family members and friends. I have concluded that whilst disclosure may be of historical interest, the health and safety of individuals must be taken into account. Some information has therefore been redacted under Section 38 of the FOI(A).

Additionally, some of the information contained within the disclosure constitutes personal information, such as names and addresses. Under FOI(A) this information is exempt under Section 40 (2) by reason of the first condition under Section 40 (3) (a) (i), as disclosure would contravene data protection principles under the Data Protection Act 2018 (DPA 2018). This is an absolute exemption and does not require a public interest test to be conducted in order for this information to be exempt from disclosure. Therefore, all personal information has been redacted.

I appreciate that this incident took place 46 years ago and the passage of time can be a factor in diminishing the applicability of exemptions to information. However, in this instance the passage of time is less relevant as the PSNI continue to investigate Troubles-related deaths and the overall balance is in favour of partial exemption.

b. (2) Four people were killed and 53 were injured when a bomb exploded without warning in a bar in the Shankill. Shots were fired as the bomb was placed.

Twenty six others were taken to the RVH suffering mainly from lacerations. Twenty seven others were taken to the MATER HOSPITAL with injuries of varying degrees of severity: one is reported SI. Severe structural damage was caused to the interior of the bar precluding the removal of samples by DIFS. An ATO will investigate further on 6 Apr 75. SOCO and the RUC TENNENT STREET are investigating.

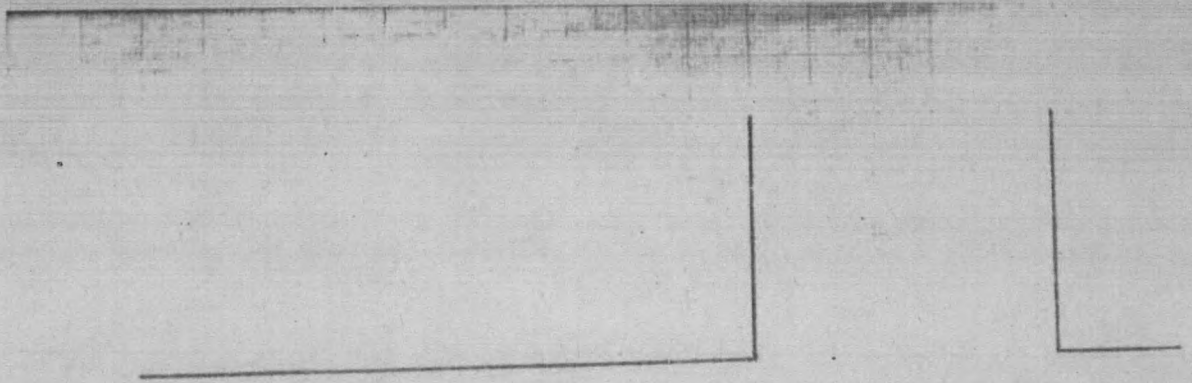

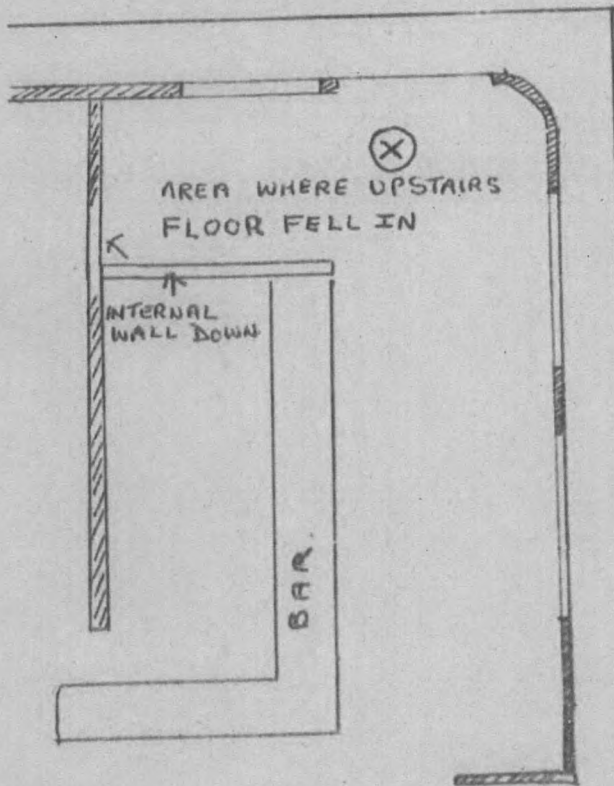

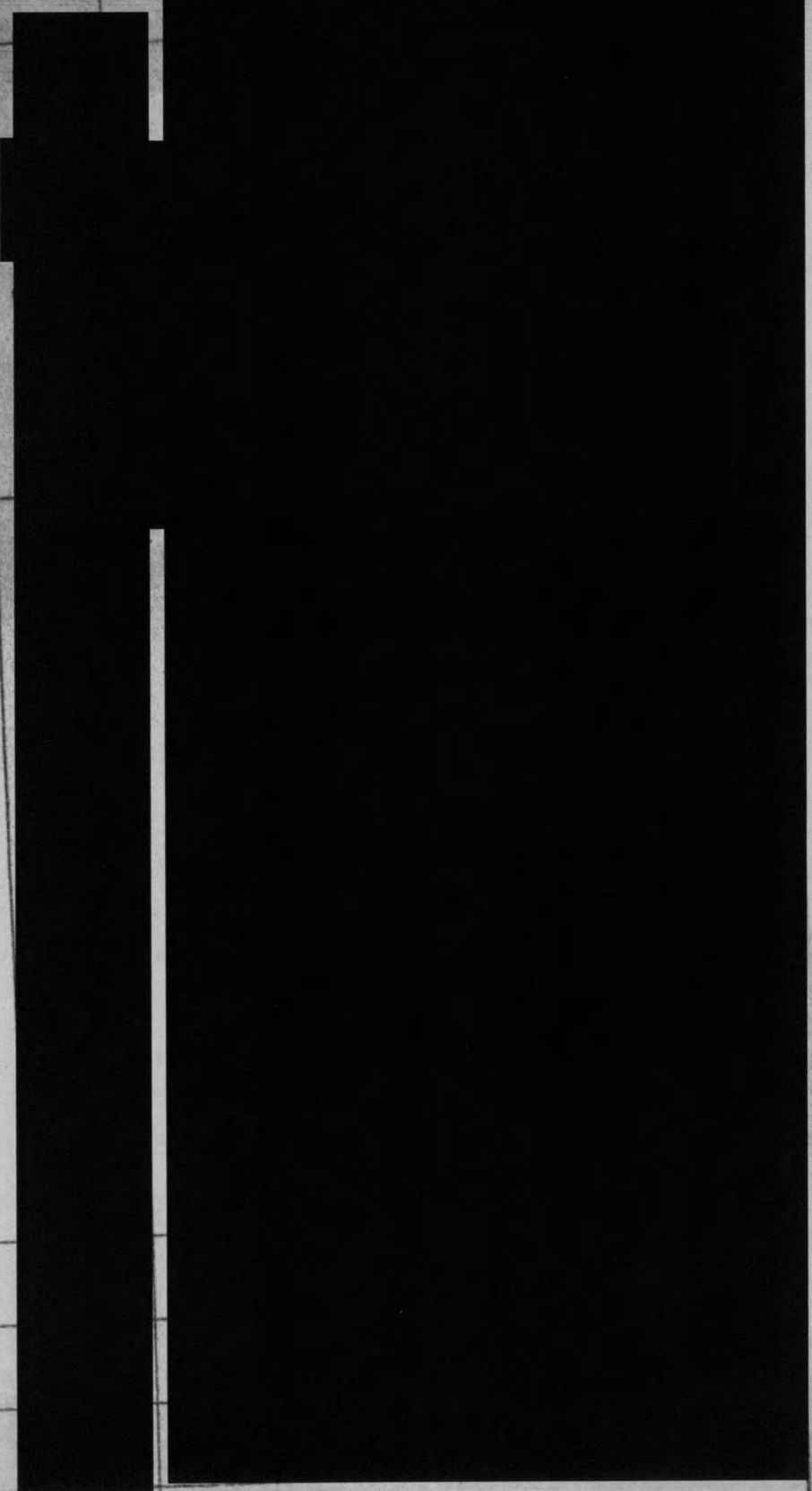
