REQUEST FOR INFORMATION – UK TROOP LEVELS DURING OPERATION BANNER

Thank you for your e-mail dated 18 November, I can confirm that your request has been considered under the provisions of the Freedom of Information Act 2000 (FOI (A)), and the process is now complete.

You asked the following:

"I'm looking for data on UK troop levels during Operation Banner, broken down by month. This data will be used in an academic paper that seeks to help answer the question of whether or not increased troop levels reduces violence or not."

We have now completed a search for the information you requested, unfortunately we do not have a breakdown of the information in the format requested.

Under Section 16 of the Act (Duty to provide advice and assistance), I can advise that the information for the number of UK troop levels in Northern Ireland during Operation Banner on a yearly basis can be found at the following links:
