# JUDGMENT AT AN ATTENDED OPEN PRELIMINARY HEARING

HAVING determined that it is in the interests of justice to extend time, the time for all four Respondents to submit their Response is extended to 19 July 2021 and the time for formal completion of the Response Form is extended to today:

1. The Rule 21 Judgment made on 5 July 2021 and sent to the parties on 6 July 2021 is set aside and all of the Respondents have leave to defend these proceedings;

2. The full merits hearing shall now take place over 5 days on **9**, **10**, **11**, **12 and 13 January 2023** at the **Leicester Hearing Centre**, **6A New Walk**, **Leicester**, **LE1 6TE** commencing at 2.00pm on the first day and at 10.00am on the remaining days. The parties should take this as notice of that hearing.

3. A Preliminary hearing will be conducted by an Employment Judge by telephone commencing on **Wednesday 25 May 2022 at 10:00 am.** It has been given a time allocation of **90 minutes.**
